**Further Cross examination by: Sri. S.G.K., Advocate for defendant**

It is true to suggest that, I have filed a maintenance petition U/s. 125 of Cr.P.C in Crl.Misc.No.59/1999 against my husband Mohinpasha. It is true to suggest that, in maintenance petition U/s. 125 of Cr.P.C in Crl.Misc.No.59/1999 the court passed an order directing my husband to pay maintenance to my children only. It is true to suggest that, maintenance petition U/s. 125 of Cr.P.C in Crl.Misc.No.59/1999 is dismissed against me only. Certified copy of order in Crl.Misc.No.59/1999 is marked as Ex.D.5 by way of confrontation. It is false to suggest that, in maintenance petition U/s. 125 of Cr.P.C in Crl.Misc.No.59/1999, my husband has filed a will deed saying that his father Bakhar Sab has executed a will deed bearing document No.59/1985-86 dated 26-12-1985 in favour of defendant No.1 in respect of land Sy.No.235/A measuring 16 acres 9 guntas situated at Sindhanur. It is false to suggest that, inspite of submission of registered will deed bearing document No.59/1985-86 dated 26-12-1985 in maintenance petition U/s. 125 of Cr.P.C in Crl.Misc.No.59/1999 I am deposing falsely.

2. It is false to suggest that, my husband Mohin Pasha has executed a registered gift deed dated 26-08-2008 in favour of defendant No.1 in respect of item No.4 and 5 of plaint schedule property. It is false to suggest that, house property and shop are standing in the name of defendant No.1. Witness volunteers that they stand in the name of my husband. It is true to suggest that, the

defendant No.1 is in possession and enjoyment of house property and shop property i.e., item No.4 and 5. It is false to suggest that, on the basis of registered gift deed 26-08-2008, the defendant No.1 is in possession and enjoyment over plaint item No.4 and 5 properties. It is true to suggest that, after marriage of my husband with defendant No.1 his relationship became co-ordeal with her. It is true to suggest that, after marriage of my husband with defendant No.1 his relationship was not co-ordeal with me.

3. I do not know the name of my husband grand father. I do not know that one Gulam Mohammed S/o. Khaja Mohinuddin was the grand father of my husband. I do not know the fact that, father of Bhakar Sab owned a land at village Rajaldinni, Tq-Manvi. I do not know the fact that father of Bhakar Sab owned lands bearing Sy.No.37 measuring 14 acres 20 guntas situated at Rajaldinni, Tq-Manvi and Land Sy.No.35/1 measuring acres 6 guntas situated at Rajaldinni, Tq-Manvi.

4. I do not know fact that, land Sy.No.107/A measuring 7 acres 18 guntas situated village Sindhanur was earlier standing in the name of Bhakar Sab S/o. Gulam Mohammed. It is true to suggest that, Bhakar Sab was the only son to his parents. I do not know fact that, land Sy.No.107/A measuring 7 acres 18 guntas situated village Sindhanur came to Bhakar Sab from his father.

5. It is false to suggest that, defendant No.1 has become owner and possessor of land Sy.No.235/A measuring 16 acres 9 guntas on the basis of registered will deed executed by deceased Bhakar Sab. It is false to suggest that, I came to know about execution of registered

will deed during 1999 itself. It is false to suggest that, I have filed this false suit inspite of knowing of execution gift deed and registered will deed. It is false to suggest that, I am deposing falsely inspite of knowing of the fact that, Gulam Mohammed was the son of Khaja Mohinuddin. It is false to suggest that, I am deposing falsely that if I admit the fact that Gulam Mohammed S/o. Khaja Mohinuddin was the owner and possessor of Sy.No.37 and Sy.No.35/1 both situated at village Rajaldinni, Tq-Manvi and land Sy.No.107/A situated at village Sindhanur, it may become adverse to me, therefore, I am deposing falsely. I do not know fact that, father of Gulam Mohammed one Khaja Mohinuddin was used to be called as Jafar Sab. It is false to suggest that, I have produced record of rights in respect of land Sy.No.107/A of village Sindhanur in Crl.Misc.59/1999.
