ORDERS ON COMMITTAL U/SEC.209 OF CR.P.C.

Accused is present.

2. The PSI of Jewargi has filed charge sheet against accused for the offence punishable U/Sec.306 of I.P.C.

3. After filing of the charge sheet, cognizance for the above said offence has been taken and charge sheet copy furnished to the accused as per Sec.207 of Cr.P.C. The accused is on bail.

4. Heard learned A.P.P. and accused regarding committal of the case.

5. Learned A.P.P. submits that the above said offence, which is exclusively triable by the Court of Sessions, Hence, this case has

to be committed to the Hon'ble Principal District and Sessions Court, Kalaburagi.

6. Perused the charge sheet and materials placed on record. On scrupulous reading of the entire record of this case, it reveals that the offences alleged against the accused are U/Sec., 306 of I.P.C. Further the Jewargi Police have registered F.I.R. against the accused persons on 11.04.2021 and submitted charge sheet on 22.08.2022. The above said offence punishable U/Sec.306 of I.P.C., is exclusively triable by the Hon'ble Principal District and Sessions Court Kalaburagi. The case ought to have been committed to the Hon'ble Principal District and Sessions Court Kalaburagi within six Weeks from the date of submission of the charge sheet, but it was not committed due to want of surety. Hence Considering all these aspects and the alleged offence against the accused, it is fit case for committal to the Hon'ble Principal District and Sessions Court Kalaburagi. Hence, I proceed to pass the following:

ORDER

This case is stand committed to Hon'ble Principal District and Sessions Court Kalaburagi acting U/Sec.209 of Cr.PC for trial.

The Accused is hereby directed to appear before the Hon'ble District and Sessions Court, Kalaburagi after receipt of summons.

The Accused shall execute personal bond for Rs.50,000/- and to furnish surety to ensure his appearance before the Hon'ble District and Sessions Court, Kalaburagi.

IO is directed to deposit the case properties to the Hon'ble District and Sessions Court, Kalaburagi with intimation to this court if any.

Office is hereby directed to notify the learned Public Prosecutor regarding the committal of this case.
