Examination-in-Chief: Public Prosecutor:

Accused persons before the court are known to me. Deceased Sukanya is my daughter. Now my daughter is dead.

2. Two years before the death she has married with A1 Hanumantharaju. At the time of wedding I had given cash of Rs.50,000/-, gold ring, Gold Chain to A1 on their demand and gold to my daughter in the form of jewels. I gave my daughter gold Thali Chain, Hangings, ear drops and ring. Wedding was performed in the Chowtry, Ullenahalli, Anjaneya Swamy Temple. After marriage my daughter was in the matrimonial home. My son in law – A1 is a BMTC Driver. Husband and wife were

have for 1 year. They had a baby daughter. Later accused persons demanded almera, coat, Mancha and I also provided them. They were harassing my daughter always to bring Rs.30,000/- from my house. Then my daughter came and intimated. At that time we did not have so much of money. Then myself and my brother CW2-Krishnappa went there and requested them to give some time to pay the amount and left her in the matrimonial home.

3. On 18-5-2012, at 2 pm one Ellappa telephoned and intimated that my daughter is dead. By about 4.30 pm myself and our relatives reached the Gollaradoddi. Then we enquired neighbors who told us that since 9 am on that quarrel was happening in their house as they were demanding to the deceased to get the money. When we went to the spot, we saw the dead body over a bed in front of the house and grand daughter was also there near the dead body and all the accused persons had left the spot. Neighbors had told me that accused persons were assaulting her on the same day in the morning demanding money. Hence I say that on account of dowry harassment the accused persons before the court are responsible for the death of my daughter.

4. Then on the same day we came to Ramanagara and lodged complaint which is marked as Ex.P1 and my signature is Ex.P1(a). Death of my daughter is within two years since her marriage.

5. Then police along with their staff came to the same and conducted panchanama near the house of accused persons and took my signature. Later body was sent to Rajarajeswari Hospital for P.M. The said panchanama is Ex.P2 and my signature is Ex.P2(a). I have produced wedding photographs, wedding card and also the photographs taken at the time of P.M. Now I see the wedding photographs which are marked as Ex.P3 to Ex.P10. Ex.P11 is Wedding Card in the cover.

6. Photographs of the dead body taken were in a cover and the same is taken out in open court which contained four photograph respectively marked as Ex.P12 to 16. After PM dead body was handed over to our custody for funeral.

7. Police later recorded my further statement in which it is mentioned that in spite of due search in and around the premises, no poison bottle and other articles were not traced. We were given gold hangings and ring by police.

8. The clothes were shown in open court and witness identified them as MO1 to 4 respectively blue underwear, brown blouse, brown petticoat and pink design saree.
