1. Sri.Kiran S., S/o Shivaramu, Aged about 23 years, R/at Hulivana Village, Keregodu Hobli, Mandya Taluk and District.

2.Sri. Kishora K. S/o Late. Kubendra Rao, aged about 23 years, R/at No.8/3, 3rd Cross, 6th Block, Rajajinagara, Bengaluru.

3. Sri. Ajith S/o Shivalinga, aged about 25 years, R/at No.145, 1st Cross, 6th Block, Rajajinagara, Bengaluru.

4. Sri. Sunil Kumar M., S/o Manohar, aged about 25 years, R/at 8th Cross, K.P Agrahara, Bengaluru.

as follows:

That you, on 12.09.2021 at 10.30 PM at Chikkanna Palya Village, Thavarekere Hobli, in Kengeri Main Road in front of Sri.Krishna Industry Factory, in order to commit robbery assembled and restrained Sri. Manish Kumar Singh and you, the 2nd Accused stabbed by steel Knife to his head, that you, the 1st Accused stabbed by Iron Knife to his forehead and chest, that and thereby you committed his murder intentionally causing his death and thereby in furtherance of your common intention committed an offence punishable under Section 302 Read With Section 34 of Indian Penal Code and within my cognizance.

Secondly,

That you on the same day time and place attempted to commit robbery and voluntarily caused hurt to said Sri. Manish Kumar Singh and thereby in furtherance of your common intention committed an offence punishable under Section 394 Read With Section 34 of Indian Penal Code and within my cognizance.

And lastly,

That you on the same day time and place voluntarily caused hurt to CW 1/ Sri.Ankur Mura, CW2/ Sri. Bikas Ray Gatavar, CW3/Sri. Lankesh Kumar Sharma, CW4/Sri.Sushanth Kumar Behera,

CW5/Sri.Jyothidas and CW6/Sri.Mahesh Kumar Shaha, who came to rescue Sri. Manish Kumar Singh and thereby in furtherance of your common intention committed an offence punishable under Section 324 Read With Section 34 of Indian Penal Code and within my cognizance.

And, I hereby direct that you be tried on the above said charges by this Court.
