I, **Sri.G.D.Mahavarkar**, M.A.,LL.B(Spl), M.L. (Lab & Indstrl Rlns & Adm. Laws), LL.M (Business Laws), M.Phil-in-Law (Juridical Science), I Additional Dist. & Sessions Judge & Special Judge, Ramanagara, do hereby charge you:-

1. Rangaswamy S/o Kalaiah,
Aged of 29 years,
2. Kalaiah S/o Kariyappa,
Aged of 55 years,
3. Shivamma W/o Kalaiah,
Aged of 50 years,
A1 to 3 are R/at Muttasagara,
Gollarahatti, Kuduru Hobli,
Magadi Taluk,
Ramanagara District.

as follows :

That, on 05.03.2016, you the accused No.1 having loved the CW.1 married in a Devasthanam in presence of CW.4 as intercaste marriage, in respect of which, the CW.5 having come to now, he secured you the accused No.1 & the CW.1-complainant to his village & gave 50 grams of golden ornaments with Rs. One lakh in presence of CW.6, to lead the happy married life & accordingly, you the

accused No.1 & the CW.1-complainant lead the happy married life, by virtue of which, the CW.1 gave birth to a baby-girl & on 17.03.2020 you the accused No.1 took the CW.1-complainant with the child to your Gollarahatti village in Kuduru Hobli, but you the accused No.2 & 3 did not allow the said CW.1-complainant inside the house demanding for bringing the dowry amount further-more, during which time, you the accused No.1 left the CW.1-complainant & the child there itself & went-away & on the same day, the CWs.5 to 7 though compromised & left there the CW.1-complainant along-with the child, you the accused Nos.1 to 3 in furtherance of common intention, subjected the said CW.1-complainant to the cruelty & harassment and thereby, committed offences punishable U/s **498A R/w Sec. 34 of IPC** and within the cognizance of this court of Sessions.

Secondly, on the above said date, time and place, you the accused No.1 to 3 in furtherance of common intention, having harassed & subjected the CW.1-complainant to the cruelty, on 20.03.2020, while the CW.1 was in front of the house of you the accused Nos.2 & 3, you the accused Nos.2 & 3 raised the scramble with her &

abused her in filthy language intentionally with an intent to provoke her to break the public peace and thereby, committed the offence punishable U/Sec. **504 R/w Sec. 34** of IPC and within the cognizance of this court of Sessions.

Thirdly, on the above said date, time and place, you the accused No.1 to 3 in furtherance of common intention, having harassed & subjected the CW.1-complainant to the cruelty, on 20.03.2020, while the CW.1 was in front of the house of you the accused Nos.2 & 3, you the accused Nos.2 & 3 raised the scramble with her & criminally intimidated by threatening to her life with dire-consequences and thereby, committed the offence punishable U/Sec. **506 R/w Sec. 34** of IPC and within the cognizance of this court of Sessions.

Fourthly, on the above said date, time and place, you the accused Nos.1 to 3, knowing fully-well that the complainant/CW1 belonged to Hindu Adi-Karnataka sub-caste, coming within the category of the Scheduled Caste and criminally intimidated, by threatening to her life, with dire consequences and thereby, committed the offence punishable U/Section **3(1)(r)** of The SC/ST (P.A.)

Amendment Act-2015, and within the cognizance of this court of Sessions.

Fifthly, on the above said date, time and place, you the accused Nos.1 and 3, knowing fully-well that the complainant/CW1 belonged to Hindu Aadi-Karnataka sub-caste, coming within the category of the Scheduled Caste abused her in filthy language in the name of her sub-caste, intentionally to insult and degrade in the public view and caused atrocity against her and thereby, committed the offence punishable U/Section **3(1)(s)** of The SC/ST (P.A.) Amendment Act-2015, and within the cognizance of this court of Sessions.

Lastly, on the above said date, time and place, you the accused Nos.1 and 3, knowing fully-well that the complainant/CW1 belonged to Hindu Aadi-Karnataka sub-caste, and committed the offences against her punishable under the Indian Penal Code with fine and thereby, committed the offence punishable U/Section **3(2) (va)** of The SC/ST (P.A.) Amendment Act-2015, and within the cognizance of this court of Sessions.

And I hereby direct that you to be tried by this court
for the above said charges.
