On 01.04.2024, at about 6.30 p.m. in the evening, when the CW.4-Ningaiah had been to

put the milk to the milk-diary, there being the affray between 2 groups, due to which, there was the delay in receiving the milk; wherefore, the CW.1-complainant having asked to receive the milk by giving-up the squabble between the said groups, you the accused NO's.1 to 6 in prosecution with common object formed an unlawful assembly with an intention to commit rioting & thereby, committed the offence punishable **U/section 143 read with Sec. 149 of IPC** and within the cognizance of this court of Sessions.

Secondly, on the above said date, time & place, you the accused NO's.1 to 6, in prosecution with common object formed an unlawful assembly & raised the squabble with the CW.1 by holding his collars & you the accused No.1 torn the clothes & slapped on his cheek & you the other accused persons assaulted him with your hands & legs & caused the simple hurt and thereby, committed the offence punishable **U/section**

323 read with Sec. 149 of IPC and within the cognizance of this court of Sessions.

Thirdly, on the above said date, time & place, you the accused NO's.1 to 6, in prosecution with common object formed an unlawful assembly & raised the squabble with the CW.1-complainant & abused him in filthy language intentionally with an intent to provoke him to break the public peace & thereby, committed the offence punishable **U/section 504 read with Sec.149 of IPC** and within the cognizance of this court of Sessions.

Fourthly, on the above said date, time & place, you the accused NO's.1 to 6, in prosecution with common object formed an unlawful assembly & raised the squabble with the CW.1-complainant & criminally intimidated by threatening to his life with dire-consequences & thereby, committed the offence punishable **U/section 506 read with**

Sec. 149 of IPC and within the cognizance of this court of Sessions.

Fifthly, on the above said date, time & place, you the accused NO's.1 to 6, in prosecution with common object formed an unlawful assembly & raised the squabble with the CW.1-complainant, & you the accused NO's.1 to 3 assaulted the CW.1, for which you the accused NO's.4 to 6 instigated & abetted them & thereby, you the accused NO's.4 to 6 committed the offence punishable **U/section 114 read with Sec. 149 of IPC** and within the cognizance of this court of Sessions.

Sixthly, on the above said date, time and place, you the accused NO's.1 to 6, knowing fully-well that the complainant/CW1 belonged to Hindu Aadi-Dravida sub-caste, coming within the category of the Scheduled Caste, criminally intimidated, by threatening to his life, with dire consequences and thereby, committed the offence punishable **U/Section 3(1)(r) of The SC/ST (P.A.) Amendment**

Act-2015, and within the cognizance of this court of Sessions.

Seventhly, on the above said date, time and place, you the accused Nos.1 to 6, knowing fully-well that the complainant/CW1 belonged to Hindu Aadi-Dravida sub-caste, coming within the category of scheduled caste, abused him in filthy language in the name of his sub-caste, intentionally to insult and degrade in the public view and caused atrocity against him and thereby, committed the offence punishable **U/Section 3(1)(s) of The SC/ST (P.A.) Amendment Act-2015**, and within the cognizance of this court of Sessions.

Lastly, on the above said date, time and place, you the accused Nos.1 to 6, knowing fully-well that the CW.1 belonged to Hindu Aadi-Dravida sub-caste, committed the offences against him punishable under the Indian Penal Code with fine and thereby, committed the offence punishable **U/Section**

3(2)(va) of The SC/ST (P.A.) Amendment Act-2015, and within the cognizance of this court of Sessions.

And I hereby direct that you to be tried by this court for the above said charges.
