as follows:

That you Accused No.1 on 28.10.2022 at 11.30 AM, agreed with Accused No.2 and 3 in Sowmya Tea Stall and provision Store of one Swamy, situated on Iggalur-Channapatna main Road, Channapatna Taluk, criminally conspired to commit murder of Renukardhya @ Shivu and thereby committed an offence punishable under Section 120-B of Indian Penal Code and within my cognizance.

Secondly, that on above date at about 11.00 P.M. you

Accused No.1 along with Accused No.2 and 3 in furtherances of your common intention near the house of Renukardhya @ Shivu situated at Nunnuru Village, Virupakshipura Hobli, Channapatna Taluk pulled Renukardhya @ Shivu, accused No.2 beat on the head and shoulder of Renukardhya @ Shivu by a club, Accused No.3 beat on the head and limbs of Renukardhya @ Shivu by a club and you Accused No.1 hold both the hands of Renukardhya @ Shivu firmly and thereafter you accused No.1 along with accused No.2 and 3 brought Renukardhya @ Shivu towards Neraluru and

by 01.30 A.M. of 29.10.202 you accused No.1 along with accused No.2 and 3 committed the murder of Renukardhya @ Shivu intensionally by beating all over the body of Renukardhya @ Shivu in land bearing Sy.No.230/1, situated at Neraluru Village, Virupakshipura Hobli, Channapatna Taluk and thereby committed an offence punishable under Section 302 R/w 34 of Indian Penal Code and within my cognizance.

I hereby direct that you be tried by this court for the said charge.
