CHARGE

I, Smt. Uma.M.G., Prl. District & Sessions Judge,
Ramanagara, hereby charge you;

1. Ramanna S/o. Thammaiah @
Yalakkaiah, Aged about 63 years.
(Abated)
2. Gowdaiah @ Gowda S/o. Ramanna,
Aged about 36 years.
3. Manjunatha @ Manja S/o. Ramanna,
Aged about 37 years.
4. Kavitha @ Lakshmidevi W/o.
Manjunatha, Aged about 23 years.
5. Thayamma W/o. Ramanna, Aged about
58 years.

All are R/o. Dandenahalli Village,
Thippasandra Hobli, Magadi Taluk,
Ramanagara District.

as hereunder:-

1. That you accused Nos. 2 to 5 along with deceased – Accused No.1 being the members of unlawful assembly, with the common object of assembly and making an attempt on the life of C.W.2, when C.Ws. 2 and 3 were sitting on the Ashwatta Katte on 14.11.2014 in between 10.30 and 11.00 a.m. in front of the house of C.W.1 – Geetha at Dandenahalli Village and thereby committed an offence punishable U/Sec. 143 R/w. 149 of I.P.C. and within my cognizance.

2. That you accused Nos. 2 to 5 along with deceased – Accused No.1, on the above said date, time and place, being the members of the unlawful assembly and in prosecution of the common object of the said assembly, committed the offence of rioting and thereby committed an offence punishable U/Sec. 147 R/w. 149 of I.P.C. and within my cognizance.

3. That you accused Nos. 2 to 5 along with deceased – Accused No.1, on the above said date, time and place, being the members of the unlawful assembly and in prosecution of the common object of the said assembly, of which you accused Nos.1 to 5 assaulted on the body of C.W.1 with hands and pushed her with legs and caused simple injuries to her and thereby committed an offence punishable U/Sec. 323 R/w. 149 of I.P.C. and within my cognizance.

4. That you accused Nos. 2 to 5 along with deceased – Accused No.1, on the above said date, time and place, being the members of the unlawful assembly and in prosecution of the common object of the said assembly, of which you accused No.1 assaulted C.W.1 with an iron rod on her right ear, you Accused No.2 assaulted C.W.2 with a motor cycle rod on his right side head, right thigh, right knee and on head, you Accused No.3 assaulted C.W.3 who came to pacify the quarrel, with a club on his head and caused simple injuries to them and thereby committed an offence punishable U/Sec. 324 R/w. 149 of I.P.C. and within my cognizance.

5. That you accused Nos. 2 to 5 along with deceased – Accused No.1, on the above said date, time and place, being the members of the unlawful assembly and in prosecution of the common object of the said assembly, committed criminal intimidation by threatening C.Ws.1 to 3 to cause their death and thereby committed an offence punishable U/Sec. 506 R/w. 149 of I.P.C. and within my cognizance.

6. That you accused Nos. 2 to 5 along with deceased – Accused No.1, on the above said date, time and place, being the members of the unlawful assembly and in prosecution of the common object of the said assembly, of which you Accused Nos.1 to 5 outraged the modesty of C.W.1 by pulling her tuft in the public place and thereby committed an offence

punishable U/Sec. 354 R/w. 149 of I.P.C. and within my cognizance.

7. That you accused Nos. 2 to 5 along with deceased – Accused No.1, on the above said date, time and place, being the members of the unlawful assembly and in prosecution of the common object of the said assembly, of which you accused No.1 caused bleeding injury to C.W.1 by assaulting with an iron rod on her head and chest, with such intention or knowledge and under such circumstances that had the act of yours caused death of C.W.1, you would have been guilty of murder and thereby committed an offence punishable U/Sec. 307 R/w. 149 of I.P.C. and within my cognizance

And I hereby direct you to be tried by this court on the aforesaid charges.
