I, **Sri.G.D.Mahavarkar**, M.A.,LL.B(Spl), M.L. (Lab & Indstrl Rlns & Adm. Laws), LL.M (Business Laws), M.Phil-in-Law (Juridical Science), I Additional Dist. & Sessions Judge & Special Judge, Ramanagara, do hereby charge you:-

Ramanagara District.

as follows :

That, on 15.08.2023, at about 5.00 p.m., in the evening, in the land bearing Sy.No.83 of Sugganahalli village, near Lakkasandra village in Ramanagara taluk, within the jurisdiction of Ramanagara Rural P.S., while the CWs.1 & 2 were ploughing the land with the help of the tractor belonging to the CW.3, you the accused Nos.1 & 2

in furtherance of common intention unlawfully trespassed into their land & raised the scramble with them & thereby, committed the offence punishable U/Sec.**447 read with sec.34 of IPC** and within the cognizance of this court of Sessions.

Secondly, on the above said date, time & place, you the accused Nos.1 & 2, in furtherance of common intention, raised the scramble with the CWs.1 & 2 & you the accused No.1 assaulted on the left shoulder of the CW.1 & on his cheek with your hands & you the accused No.2 dragged the CW.1 & trampled & stampede with your legs & caused the simple hurt & thereby, committed the offence punishable U/Sec.**323 read with sec.34** of IPC and within the cognizance of this court of Sessions.

Thirdly, on the above said date, time & place, you the accused Nos.1 & 2, in furtherance of common intention, raised the scramble with the CWs.1 & 2, & you the accused No.1 snatched the Oppo mobile-phone from the hands of the CW.2 & assaulted on the head of the CW.2 & caused the simple injury & thereby, committed the offence punishable U/Sec.**324 read with sec.34** of IPC and within the cognizance of this court of Sessions.

Fourthly, on the above said date, time & place, you the accused Nos.1 & 2, in furtherance of common intention, raised the scramble with the CWs.1 & 2 & you the accused No.2 snatched-away the Oppo mobile-phone from the hands of the CW.2 & damaged it, & caused the loss to the extent of Rs.20,000/- & thereby, committed the offence punishable U/Sec.**427 read with sec.34** of IPC and within the cognizance of this court of Sessions.

Fifthly, on the above said date, time & place, you the accused Nos.1 & 2, in furtherance of common intention, raised the scramble with the CWs.1 & 2 & abused them in filthy language intentionally with an intent to provoke them to break the public peace & thereby, committed the offence punishable U/Sec.**504 read with sec.34** of IPC and within the cognizance of this court of Sessions.

Fifthly, on the above said date, time & place, you the accused Nos.1 & 2, in furtherance of common intention, raised the scramble with the CWs.1 & 2 & criminally intimidated by threatening to their lives with dire consequences & thereby, committed the offence

punishable U/Sec.**506 read with sec.34** of IPC and within the cognizance of this court of Sessions.

Sixthly, on the above said date, time and place, you the accused Nos.1 & 2, raised the scramble with the CWs.1 & 2, knowing fully-well that the CWs.1 & 2 belonged to Hindu-Aadi Karnataka sub-caste, coming within the category of the Scheduled caste and criminally intimidated, by threatening to their life, with dire consequences and thereby, committed the offence punishable U/Section **3(1)(r) of The SC/ST (P.A.) Amendment Act-2015**, and within the cognizance of this court of Sessions.

Seventhly, on the above said date, time and place, you the accused Nos.1 & 2, having raised the scramble with the CWs.1 & 2, knowing fully-well that they belonged to Hindu-Aadi Karnataka sub-caste, coming within the category of the Scheduled Caste, abused them in filthy language in the name of their sub-caste intentionally to insult & degrade them in the public view & caused the atrocity against them and thereby, committed the offence punishable U/Section **3(1)(s) of The SC/ST (P.A.)**

Amendment Act-2015, and within the cognizance of this court of Sessions.

Lastly, on the above said date, time and place, you the accused Nos.1 & 2, knowing fully-well that the CWs.1 & 2 belonged to Hindu-Aadi Karnatka sub-caste, coming the category of the scheduled-caste, wrongfully attempted to occupy & cultivate the land, which was in possession of them (CWs.1 & 2) and thereby, committed the offence punishable U/Section **3(1) (f) of The SC/ST (P.A.) Amendment Act-2015**, and within the cognizance of this court of Sessions.

And I hereby direct that you to be tried by this court for the above said charges.
