COMMITTAL ORDER

The PI of Bidadi P.S., Ramanagara has filed a Charge sheet against the Accused No.1 to 4 alleging that they have committed the offence punishable u/Sec.310(2) and 190 of BNS. Thereafter, this court took cognizance of the offence mentioned supra in accordance with Sec.190(1)(b) of Cr.P.C.,



2. On perusal of the materials available on record and hearing the learned Senior A.P.P and the learned Defence Counsel, it is clear that the offence punishable u/Sec.310(2) and 190 of BNS is exclusively triable by the Hon'ble Sessions Court. Wherefore, it is needful to commit the case to the Hon'ble Sessions Court as required u/Sec.232 BNS.

3. Accused No.1 to 4 are in J.C. Hence, the copies of the charge sheet on behalf of the Accused No.1 to 4 has been supplied to them through the Jail Superintendent, Ramanagara District Prison. As the Accused No.1 to 4 are in J.C., there is no hindrance to secure their presence before the Hon'ble Sessions Court for trial. In the result, I proceed to pass the following:-

ORDER

- *By exercising the power conferred under Sec.232 of the BNSS, this case stands committed to the Hon'ble Court of Sessions, Ramanagara for trial.*
- *Onward all the records duly indexed together with all the properties deposited in this case immediately to the Hon'ble Court of Sessions, Ramanagara.*
- *Notify the Public Prosecutor, Ramanagara*



regarding the committal of this case to the Hon'ble Court of Sessions, Ramanagara.

- *As the Accused No.1 to 4 are in JC, office is directed to intimate to the jail authority of District Prison, Ramanagara, to produce the Accused is before the Hon'ble Sessions Court, Ramanagara as and when directed to do so.*
