Chief-Examination by learned A.P.P. :-

From the past 35 years I am practicing as an advocate in Ramanagara town. I am also attending the office of my colleague situated at Bengaluru in certain cases.

2. On 13-4-2011 after completion of work in the Bengaluru Office, I left at 10 pm. At about 10.30 pm I reached Ranganatha Lodge situated at B.M.Road. On that day on account of erection of barricade, police left me near to a spot in front of BHEL Factory. At about 11 pm on BTS Bus came and I boarded the said bus and I got down at Bidadi. Then I saw one vehicle came announcing that passengers going to Channapatna Ramanagara and

further place may get in. I boarded the said vehicle and in the vehicle I saw around 5 persons aged between 22 to 25 years. I also saw deadly weapons like Macchu, Long, in the dikki. Then one person made me to sit in the middle and he sat below the driver seat. When vehicle came near the Ashrama of Nithyananda Swamy, Dasappana doddi. Then two persons sitting on both the sides removed button knives and kept it near the ears and then also slapped me even though I told them to spare me and whatever I have will be given to you. The driver also instigated him to assault and to throw me outside the car. One person near KMF, snatched away a gold chain weighting 22 grams with the help of knife from my neck. One persons snatched away my mobile and return the Sim and took the mobile. They took away one gold ring around 4 grams with 6 white stones. They took away one gun mettle ring weighing 8 grams. Then I had cash of Rs.10,000/- in denomination of 50, 100 and 500 and it was taken away. They had covered my eyes with my shirt only so that nothing was visible to me.

3. They in order to snatch away all the items, turned the car around thrice. Near Lakshmi Farm,

they pushed me out of the vehicle. I fell down on the foot bath. Then I tried best to note the vehicle number and it was impossible. Then slowly I walked and reached Coffee day and with the help of my sim I contacted my son and he came and took me around 1 am. On the same day during morning hours I lodged complaint.
