COMMITTAL ORDER

The PSI of Ijoor Police, Ramanagara, Bengaluru South District has filed the final report against the Accused alleging that she has committed the offence punishable under Sec.109, 115(2), 118(1), 352 r/w 3(5) of B.N.S., 2023. Thereafter, this court took cognizance of the offences mentioned supra in accordance with Sec.190(1)(b) of Cr.P.C., corresponding provision Sec.210 of B.N.S.S., 2023.

2. On perusal of the materials available on record and hearing the learned Senior A.P.P and the learned defence counsel, it is clear that the offence alleged against the Accused person punishable under Sec.109, 115(2), 118(1), 352 r/w 3(5) of B.N.S., 2023 is exclusively triable by the Hon'ble Sessions Court. Wherefore, it is needful to commit the case to the Hon'ble Sessions Court as required under Sec.232 BNS.

3. The Accused is on bail. She has been supplied with prosecution papers. To secure the presence of the Accused person before the Hon'ble Sessions Court, it is necessary to obtain security from her. Accordingly,
