**COMMITTAL ORDER**

The P.S.I., of Bidadi Police Station, Ramanagara

has filed the final report against the Accused No.1 to 9 alleging that they have committed the offences punishable under Sec.143, 323, 427, 504, 506, 327, 354 r/w 149 of the IPC. Thereafter, this court took cognizance of the offences mentioned supra in accordance with Sec.190(1) (b) of Cr.P.C.

2. On perusal of the materials available on record and hearing the learned Senior A.P.P and the learned defence counsel, it is clear that the offence alleged against the Accused persons punishable under Sec.327 of the IPC is exclusively triable by the Hon'ble Sessions Court. Wherefore, it is needful to commit the case to the Hon'ble Sessions Court as required under Sec.209 of Cr.P.C.

3. The Accused No.1 to 9 are on bail. They have been supplied with prosecution papers. To secure the presence of the Accused persons before the Hon'ble Sessions Court, it is necessary to obtain security from them. Accordingly, committal surety has been obtained for Accused No.1 to 9. In the result, I proceed to pass
