COMMITTAL ORDER UNDER SECTION 209 CR.P.C.

The Police Inspector, D.C.I.B, District Police Office, Bangalore District, Bangalore has filed the Charge sheet against the accused for the offences punishable under sections 143, 144, 147, 148, 341, 307, 427, 504 r/w 149 of IPC.

2. The copy of the charge sheet as required under Section 207 of Cr.P.C has been furnished to the accused.

3. Heard, Perused. One of the offence alleged to have been committed by the accused are punishable under section 307 of IPC, is exclusively triable by the Hon'ble Court of Sessions. Hence, the case against the accused are liable to be committed to Hon'ble Sessions Court, Ramanagara.

For the above said reasons, I proceed to pass the following: -

ORDER

The accused who are on bail shall be present before the Hon'ble District and Session Court when the summons are received.

Notify the Public Prosecutor about commitment of this case to the Hon'ble Sessions Court.

No.65/1 measuring 1-12 guntas situated at Archakarahalli, Ramanagara Taluk having immovable property therein worth about Rs.30 Lakhs/-.
