1. 2. That, on the same, day, time and place, in furtherance of your common object you accused no 1 to 5 abused CW1 to CW5 in filthy language with an intention to insult them and to provoke them to break public peace and thereby committed an offence punishable u/s 504 r/w 149 of IPC and within the cognizance of this court.
3. That, on the same, day, time and place, in furtherance of your common object you accused No 1,4 and 5 assaulted CW1 with hand on his face and you accused No.1 to 5 assaulted CW2 with hand and caused simple injury to CW1 and CW2 and thereby committed an offence punishable u/s 323 r/w 149 of IPC and within the cognizance of this court.

4. That, on the same, day, time and place, in furtherance of your common object you accused No. 2 and 3 assaulted CW1 with peace of bricks on his face and head and caused simple injury to CW1 and thereby committed an offence punishable u/s 324 r/w 149 of IPC and within the cognizance of this court.
5. That, on the same, day, time and place, in furtherance of your common object you accused No.2 committed criminal intimidation by threatening CW1 with his life and there by committed an offence punishable U/s 506 r/w 149 of IPC and within the cognizance of this court.

And, I direct that you accused be tried on the said charge.
