the suit till realization.

c) Cost of the suit.

This suit coming for final disposal on 05.06.2026 before Sri.Venkateshappa V., Prl. Senior Civil Judge and JMFC., Channapatna in the presence of Sri.P.K.V., Advocate for Plaintiff and Defendants are placed as ex-parte.

It is ordered and decreed that, the suit of the plaintiff is partly decreed with cost.

It is further ordered and decreed that, the Defendants are liable to pay the suit claim of Rs.9,50,000/- (Nine Lakh Fifty Thousand Only) with interest at 6% per annum from the date of suit till the realization.
