ORDER

In view of National Lok Adalath, case is suomotu advanced today. The counsel for the accused filed the memo to re examination of accused. Accused is called present and he is identified by the Police Constable concerned. Copies of case documents are furnished to the Accused. He is examined under Sec.251 of Cr.P.C. The substance of accusation made for the offence under U/Sec.294(b), 323, 341, 506 IPC against the Accused, read over and explained to the Accused in Telugu, for which, Accused pleaded guilty. This court warned the accused and informed him about the

punishment prescribed for the offence committed by him. Even then the Accused is admitted the guilt. Hence, this court feels that the guilt pleaded by the Accused is true and voluntary. Accused is heard with regard to the quantum of sentence to the imposed against him. He prayed the Court to take lenient view as it was first offence. Considering the facts and circumstances of the case and voluntary admission of Accused this court feels that if fine amount is imposed against the Accused it would meet the ends of sentence. IN THE RESULT, Accused is found guilty for the offence under U/Sec.294(b), 323, 341, 506 IPC. Accordingly, the accused is sentenced to pay fine of Rs.200/- for the offence U/Sec.294(b) IPC, the accused is sentenced to pay fine of Rs.1,000/- for the offence U/Sec.323 IPC, the accused is sentenced to pay fine of Rs.500/- for the offence U/Sec.341 IPC, the accused is sentenced to pay fine of Rs.300/- for the offence U/Sec.506 IPC. In default of payment of fine, he shall undergo simple imprisonment for a period of (3) days. Total fine amount is Rs.2,000/-.
