**C H A R G E**

I, Sri. Kumar H.N., B.A.L., LL.B., Second Additional District and Sessions Judge, Ramanagara, sit at Kanakapura do hereby charge you as named above as under:

That you accused No.1 is having on CW.1 Pradeep, that on 06.12.2021 at about 7.00PM Bangalore person had dashed to the puppy belongs to the CW.1 and in this regard there is brawl between CW.1 and Bangalore person, on knowing the same on the same day at about 10.07PM, that you accused by your mobile phone number 9632833913 to the mobile phone number 9986330756 of CW.1 and on guise of puppy issue that you accused No.1 and 2 made brawl with CW.1 through phone and scolded in indecent language to the CW.1 and committed criminal intimidation by threatening CW.1, threat cause death and thereby committed an offence punishable U/s 506 R/w/section 34 of IPC and within the cognizance of this court.

On the same date, time and place, that you accused No.1 and 2 have with an intention to commit murder of CW.1, intentionally insulted the CW.1 and thereby gave provocation to CW.1 intending that such provocation would cause such CW.1 to break public place and thereby committed an offence punishable U/s 504 R/w/section 34 of IPC and within the cognizance of this court.

That on same date, after knowing the where abouts of CW.1, that you accused No.1 had illegally purchased SBML Gun, later that you accsed No.1 went near to the house of the CW.1 sutated at Kanakapura-Sangam Road, in a motor cycle bearing registration Number KA-05-JP-619 Hero Passion Pro along with the accused No.2, that on having old grudge that you accused No.1 with intention to commit of CW.1 aiming towards his trunk portion of the body and fired at that time by the slight movement of CW.1 escaped and got air fire, late the CW.1 and 2 ran away to the house of the CW.1 and after 10 minutes that you accused No.1 once again made air fire, with such a intention and knowledge and under such circumstance that had the act of yours cause death of CW.1, you would have been guilty of murder and thereby committed an offence punishable U/s 307 r/w/section 34 of IPC and within the cognizance of this court.

That you accused No.1 and 2 on the same date, time and place acquires and has in possession and carried firearm in contravention of section 3 of Arms Act 1959 and thereby committed offence punishable U/s 25 of Arms Act 1959.

And I hereby directed that you be tried by this court on the above said charges.
