Examination in Chief by learned APP:

1. I have working as medical officer at Govt. Hospital, Kanakapura. From 2008 to 2014.
2. When I was on duty On 26.05.2012 at about 3 p.m. patient by name Ravikumar K. S/o Late Konegowda aged about 30 years, R/at Kachuvanahalli Village, with history of assault by Shivalingegowda and 4 others with stick stone, etc., at 8. a.m. on 26.05.2012 at Kachuvanahalli school premises.
3. I have examined the patient and found pain and swelling on the left metacarpo phalangeal 5th joint, sutured wound on right posterior aspect of right arm lower 1/3rd, aberation with bruise on left scapular area measuring 2X16 c.m. aberation on left supra clavicular area measuring 4 X 3 c.m., bruisc on left mid arm measuring 2 X 2 c.m., pain on left calf muscle,

abretation medial aspect of left knee measuring 2 X 3 c.m. and pain over right forearm mid 1/3rd.

X-ray of left hand AP oblique, Right forearm AP lateral and left shoulder AP. On X ray I found fracture of proximal phalanx little finger on left hand.

In my opinion Injury No.1 is grievous in nature.

Injury No. 2 to 8 are simple in nature.

I had wound certificate to Sathnuru Police. Witness on seeing wound certificate identifies signature and states it is the said wound certificate he had issued Sathnuru Police. Wound Certificate is marked Ex.P1 and signature of the witness is marked as Ex.P1(a).

The above injuries can happen when one is assaulted stick and stone. The above injuries can happen when one is assaulted with stick and stone which is there before the court today.

Cross examination by Learned counsel for Accused Sri. S.D. .

It is false to suggest I have not mentioned age of injury. Witnesses volunteers that he has mentioned time of injury which corresponds to age of injuries.

Patient had come with one attendant by name Kumar.

Patient had got first aid before he came to me.

It is true to suggest I have not mentioned the same in Ex.P1 wound certificate.

Patient had not come along with Police memo.

I have not intimated to police before treating the patient. Witness volunteers that he has intimated to police after treatment.

It is true to suggest the above injuries can happen when one falls from the tree or tree falls on him.

It is false to suggest Ex.P1 wound certificate was issued as pressure was put on me.
