COMMITTAL ORDER UNDER SECTION 232 OF THE
BHARATIYA NAGARIKA SURAKSHA SANHITA-2023
(BNSS-2023)

In this case the Mines and Geology Department has filed a complaint U/sec.223 of B.N.S.S R/w Sec.22 of MMDR Act-1957 against the accused Nos.1 and 2 for the offences punishable U/Sec. 21(1), 4(1) and 4(1A) of MMDR Act 1957 and Rules 44(1) and 3(1) of KMMCR Rules (Amendment Rules of 2020).

2. After registering the case, summons was issued to the accused Nos.1 and 2.

3. In response to the summons issued against the accused persons, they have appeared before the court on 29.01.2026 and enlarged on bail. On perusal of the contents of complaint and documents produced by the prosecution prima-facie shows the case against accused persons for the

above said offences. **Accused Nos.1 and 2 have furnished surety for committal on 24.04.2026**, accordingly after taking committal surety without any delay this case is committed to the Hon'ble Court of Sessions.

4. The offences charged against the accused Nos.1 and 2 are punishable U/Sec. 21(1), 4(1) and 4(1A) of MMDR Act 1957 and Rules 44(1) and 3(1) of KMMCR Rules (Amendment Rules of 2020) and the same are exclusively triable by the Hon'ble Court of Sessions, i.e., Prl. District and Sessions Judge, Ramanagara, Bengaluru South District. Copy of prosecution papers is furnished to the accused No.1 and 2. Hence, this court is of the opinion that since this case is exclusively triable by the Hon'ble Prl. District and Sessions Judge, Ramanagara, Bengaluru South District this case is to be committed to the Hon'ble Prl. District and Sessions Judge, Ramanagara, Bengaluru South District as provided under Section 232 of B.N.S.S-2023. With these observations this court proceeds to pass the following;

ORDER

1. Acting under Sec.232 of B.N.S.S-2023 this case is committed to the Hon'ble Prl. District and Sessions Judge, Ramanagara, Bengaluru South District for trial.

2. Copy of prosecution papers is supplied to accused Nos.1 and 2 as provided under Sec.231 of B.N.S.S-2023.

3. Office is directed to submit entire records of this case and documents and articles if any forthwith to the Hon'ble Prl. District and Sessions Judge, Ramanagara, Bengaluru South District.

4. Office to notify the learned Public Prosecutor about Committal of this case.
