

ORDERS

This is the petition filed by the petitioners U/Sec.13(3)(b) of the Registration of Births and Deaths Act, seeking direction from this Court to Respondent No.1 to enter the date of death of **Smt.Puttalingamma W/o late.Chikka Channegowda**, who is the mother of the petitioner No.1 and mother-in-law of the petitioner No.2 and 3 and in the Register maintained by the Respondent No.1.

After due service of the notice on the Respondents, the Respondents have not appeared before this Court and they are absent and placed exparte.

In order to substantiate the case, the petitioner No.1 got examined on oath as PW.1 and got marked Exs.P.1 to P5 and reiterated the averments of the petition by filing his Examination-In-Chief of Affidavit.

In order to prove and substantiate his case U/Sec.13(3) of the Registration of Births and Deaths Act, 1969 and U/Rule 9(3) of Karnataka Registration of Births and Deaths Rules, 1999, PW.1 has also produced the Non-Availability Certificate as Ex.P.1, Ex.p.2 is the Genealogy certificate issued by Deputy Tahasildar, Uyyamballi Hobli, Kanakapura Taluk along with copy of G-tree, Ex.p.3 is the true copy of aadhar card of PW.1 and Ex.p.4 and 5 are the paper publications.

The PW.1 has got issued notice of the particulars pertaining to issuance of death certificate published in two local daily news papers. The said news paper publications was taken in Vishwavani and Udayakala dated 02.12.2025. The said paper publications are marked as Exs.P.4 and P.5. After news paper publications, no objection has been received with respect to the said paper publications and on enquiry, the petitioners submit that they requires the death certificate of the deceased to change the katha and pahani and other revenue records in their names.

Hence, on due perusal of the materials available on record. This court is of the opinion that the reasons and grounds stated in **Smt Muniyamma C. Sandeep Babu V/s Devegowda, The Tahsildar, 2014(1) Kar.L.J.714** has been complied by the petitioners. Hence, this court proceeds to pass the following:-

ORDER

The petition filed by the petitioners U/Sec.13(3) of the Registration of Births and Deaths Act, is hereby allowed.

The Respondent No.1 is hereby directed to enter the date of death of deceased **Smt.Puttalingamma W/o late.Chikka Channegowda**, died on **22.02.2017** at **Shettikeroddi Village, Uyyamballi Hobli, Kanakapura Taluk, Ramanagara District** in the concerned death register maintained by the respondent No.1.

The respondent No.1 is hereby directed to issue death certificate of the said **Smt.Puttalingamma W/o late.Chikka Channegowda** after collecting necessary fees from the petitioners.

The said entry shall not be a conclusive proof of death and if in case of any dispute there exists on death, the entries shall be subject to proof.
