TERMS OF COMPROMISE

- 1) The Aggrieved Person/ Applicant have voluntarily compounded the offence
punishable under section Section 12 of Domestic Violence Act, 2005 (Act
43/2005) against the respondents.

2) The Aggrieved Person/ Applicant filed a Criminal Case against the respondents U/S. 498 A before the Eluru Women police Station and the same was numbered as C.C.No. 545/2022 on the file of Junior Civil Judge- cum- Judicial Magistrate of 1st Class Bhimadole and the case was posted to 11-04-2023. The petitioner also filed D.V.C.No. 7/2021 against the respondent and his family members. The 1st Respondent filed a Divorce Case vide O.P.No. 865/2022 on the file of the Principal Family court, Hyderabad and the same is posted to 11-04-2023 for petitioner i.e., Husband of the Aggrieved person / applicant evidence.

3) The matter was amicably settled between the Aggrieved Person/ Applicant and the respondents in the presence of elders to maintain the peace and harmony in the families.

11) The above matter was compromised before the village elders. As per the compromise arrived at before Village Elders the 1st respondent has paid an amount of Rs. 9,00,000/- (Rupees Nine Lakhs Only) before the elders for which the petitioner accepted and the received the said amount towards marriage expenses, permanent alimony etc., and the Aggrieved Person/ Applicant under takes not to claim any maintenance in future against the respondent/ Husband. The articles belongs to both of the aggrieved person/ applicant and the respondents already exchanged to each other. Nothing in the hands of the both of them and both of the aggrieved person/ applicant and the respondents did not claiming anything in future.

4) The 1st respondent has paid to pay an amount of Rs 9,00,000/- (Rupees Nine Lakhs Only) as marriage expenses, Permanent Alimony and full and final settlement of maintenance to the Aggrieved Person/ Applicant before this Lok Adalat after close all the proceedings including C.C.NO. 545/2022. The Aggrieved Person/ Applicant and 1st respondent and other respondents agreed for the same.

5) The Aggrieved Person/ Applicant further agreed to withdraw the M.C.No. 8/2021 filed against the respondent.

6) The Aggrieved Person/ Applicant agreed to cooperate with the 1st respondent to take divorce from the Ho'ble Principal Family Court, Hyderabad in O.P.No. 865/2022.

7) The Aggrieved Person/ Applicant accepted the same and the Aggrieved Person/ Applicant has to take appropriate legal steps to withdraw the case in C.C.No. 545/2022 against the respondents and his relatives.
