## **AS PER JOINT MEMO**

The Petitioner having filed the claim petition claiming the compensation on account of the injuries/Death, the petitioner and the Respondent Insurance Company agreed to settle the claim in full and final settlement for Rs. 3,50,000/- (Rupees three lakh Fifty thousand only) and prays to pass an award accordingly. The Respondent agrees to deposit the said amount within three months failing which the said amount shall carry an interest at the rate of nil % from the date of the decree. (The interest of the minor will be safe guarded by making necessary deposits, as per the decree to be passed) The Petitioner is not entitled for any cost.
