### **CHARGE**

*I, Mahavir.M.Karennavar, Prl. Civil Judge & JMFC, Magadi, do hereby charge you, as follows;*

Firstly, that on 17-05-2016 at 09.0 am. in Uduvegere, Village, Madbal Hobli, Magadi Taluk, within the limits of Magadi Police Station, in prosecution of common object, you accused No.1 to 11 formed a members of an unlawful assembly assembled together with an intention to commit certain offences and thereby you accused committed an offence punishable U/Sec.143 R/w Sec.149 of Indian Penal Code and within my cognizance.

Secondly, that on the above said date, time and place, you accused No.1 to 11 formed an unlawful assembly in prosecution of common object of the said assembly committed an act of rioting with intent to commit certain offence and so as to commit an act of rioting and thereby you accused committed an offence punishable U/Sec.147 R/w Sec.149 of Indian Penal Code and within my cognizance.

Thirdly, that on the above said date, time and place, you accused No.1to11 formed an unlawful assembly in furtherance of

common intention, you accused committed criminal trespass by entering into the land at Sy.No.137/03 which is belonging to CW.1 with an intention to commit certain offences and thereby you Accused committed an offence punishable U/Sec.447 R/w Sec.149 of Indian Penal Code and within my cognizance.

Fourthly, that on the above said date, time and place, in prosecution of common object, you accused No.1 to 11 picked up quarrel with the C.W.1 & 2 and you accused No.1 to 11 voluntarily assaulted C.W.1 & 2 with your hands on them body and kicked with your legs and caused simple injury and thereby you accused have committed an offence punishable U/Sec.323 R/w Sec.149 of Indian Penal Code and within my cognizance.

Fifthly, that on above said date, time and place, in furtherance of common intention, you accused No.2,4,5 picked up quarrel with C.W.1 and 2 and made him to fell down and you accused No.4 caused hurt to CW.2 with stick on his left hand, and you accused No.2 caused hurt to Cw.2 with sickle on his finger, caused hurt to which is used as an weapon of offence likely to cause death and caused grievous hurt by dangerous weapons to CW.2 and thereby you accused have committed an offence punishable U/Sec.326 R/w Sec. 34 of Indian Penal Code and within my cognizance.

Finally, that on above said date, time and place, in prosecution common object, you accused No.1 to 11 picked up

quarrel with the C.W.1 & 2 and abused her in filthy language and thereby gave provocation to her intending or knowing it likely that such provocation will cause her to break the public peace or to commit any other offence and thereby you accused committed an offence punishable U/Sec.504 R/w Sec.149 of Indian Penal Code and within my cognizance.

And I hereby direct that you be tried on the said charge.
