**CHARGE**

**I, Sri. Shrinivasa. K. R. B.A.L.,LL.M., Prl. Civil Judge & J.M.F.C., Magadi, do hereby charge you:**

That on 30.09.2023 at 02.00 p.m., at the land bearing Sy.No.11, situated at Byalakere Village, Rajojipalyahalli, Magadi Taluk, you accused No.1 to 4 illegally trespassed into the land which belongs to CW-1 with an intent to commit an offence or to intimidate or insult or annoy CW-1

and thereby committed an offence punishable **U/Sec.447 R/W.Sec.34 of I.P.C.**, and within my cognizance.

Secondly: That on above said date, time and place, accused No.1 to 4 in furtherance of common intention, all of a sudden picked up quarrel with CW-1 and voluntarily assaulted to CW-1 with hands & legs on her face & body and you accused No.2 voluntarily assaulted to CW-1 with hands on her head, you accused No.3 voluntarily assaulted to CW-1 with legs on her waist and you accused No.4 voluntarily assaulted to CW-1 on her hands and caused simple hurt to CW-1 and thereby committed an offence punishable **U/Sec.323 R/w. Sec.34 of I.P.C.** and within my cognizance.

Thirdly: That on above said date, time and place, accused No.1 to 4 in furtherance of common intention, you accused No.2 used criminal force to CW-1 Smt. Puttalakshamma by holding her hair and pulling her saree and you accused used criminal force to CW-2 Smt. Shakuntala with an intention to outrage their modesty or knowing it to be likely that you would thereby outrage their modesty and thereby committed an offence punishable **U/Sec.354(B) R/w Sec.34 of I.P.C.** and within my cognizance.

Fourthly: That on above said date, time and place, accused No.1 to 4 in furtherance of common intention, you accused No.3 intentionally insulted to CW-1 in filthy

language and thereby gave provocation will cause CW-1 to break public peace and thereby committed an offence punishable **U/Sec.504 R/w Sec.34 of I.P.C.** and within my cognizance.

Fifthly: That on above said date, time and place, accused No.1 to 4 in furtherance of common intention, you accused No.1 voluntarily assaulted to CW-2 with a scar on her hand and caused grievous blood injury and thereby committed an offence punishable **U/Sec.324 R/w. Sec.34 of I.P.C.** and within my cognizance.

Lastly: That on above said date, time and place, accused No.1 to 4 in furtherance of common intention, you accused No.1 committed criminal intimidation by threatening to the life of C.W.2 with intent to kill her and with dire consequence of her life and thereby committed an offence punishable **U/Sec.506 R/w.Sec.34 of I.P.C.** and within my cognizance.

And I hereby direct that you be tried on the said charge.
