SUBSTANCE OF ACCUSATION

It is alleged by the prosecution that, on 10-08-2014 at 8.30 p.m. near Kalya colony bustand, Magadi-Kunigal Road, within the limits of Magadi police, you accused being the driver of Tata ACE bearing Reg. No.KA-41-A-7427 drove the same in rash and negligent manner so as to endanger human life and personal safety of others and thereby you accused have committed an offence punishable U/Sec.279 of Indian Penal within my cognizance.

It is further alleged by the prosecution that, on the above said date, time and place, you accused by driving the above said Vehicle in the above said manner, dashed to Akram Baijuf Shek @ Akram Pasha's and sons 1) Umekh Ubra Taj @ Umekh Ubra Akram Shek, 2) Shahil Akram Shek, 3) Shoheb Akram

Sheik, due to which Umekh Ubra Taj @ Umekh Ubra Akram Sheik, Shahil Akram Sheik, Shoeib Akram Sheik fell down and sustained simple injuries and thereby you accused have committed an offence punishable U/Sec.337 of I.P.C. within my cognizance.

It is alleged by prosecution that, on the above said date, time and place during the course of same transaction you accused being the rider of above mentioned offending vehicle, drove the same in a high speed and in a rash and negligent manner and dashed to Akram Baiju Shek@ Akram Pahsa and umek Ubra @Umek Ubra Akram Shek due to which fell down and sustained grievous injuries subsequently they succumbed to those injuries and thereby you accused committed an offence punishable U/Sec.304(a) of Indian Penal Code and within my cognizance.

It is further alleged by the prosecution that, on the above said date, time and place, you accused ride the above stated offending vehicle, plying the same without having valid Driving License and caused accident and thereby you accused have committed an offence punishable U/Sec.181 M.V. Act within my cognizance.

It is further alleged by the prosecution that, on the above said date, time and place, you accused being the ride of above mentioned offending vehicle ride the same rash and negligent

manner and caused accident, and have not produced the documents of vehicle pertaining to insurance etc., to the police station and thereby you accused have committed an offence punishable U/Sec.196 of M.V. Act within my cognizance.

And I hereby direct that you be tried by this court on the Said Plea.
