I, Shrinivasa K. R., B.Sc., LL.B., LL.M., Prl. Civil Judge & JMFC, Magadi, do hereby charge you:

It is alleged against you accused no.1, 4, 5, 8 & 9 along with accuse No.2, 3, 6 & 7 that, on 06-06-2018 at about 10:00 a.m. in front of the house of accused No.1 on the cement road at Parangichikkanapalya, accused No.1 & 4 intentionally insulted CW-1 in filthy language and thereby gave provocation will cause CW-1 to break public peace and thereby committed an offence punishable U/Sec.504 R/W. Sec.149 of IPC and within my cognizance.

Secondly, that on the above said date, time and place, in prosecution of common object, you accused No. no.1, 4, 5, 8 & 9 along with accuse No.2, 3, 6 & 7, accused No.5 & 8 voluntarily assaulted CW-1 with hands and caused simple injury and thereby committed an offence punishable under Sec.323 R/W. Sec.149 of IPC and within my cognizance.

Lastly, that on the above said date, time and place, in prosecution of common object, you accused No.1, 4, 5, 8 & 9 along with accuse No.2, 3, 6 & 7, accused No.9 criminally intimidated CW.1 by threatening her that he will kill her with an intent to cause alarm in her and thereby committed an offence punishable U/Sec.506 R/W. Sec.149 of IPC and within my cognizance.

And I hereby direct that you be tried on the said charge..
