This is the petition filed by the petitioners under Section 166 of Motor Vehicle Act, claiming for grant of compensation on account of death of the deceased in the motor vehicle accident.

The claim petition coming on this day for final disposal before Sri. Dindalkopp Shivaputra, B.Sc., LL.B. (Spl), VI Addl. Dist. & Sessions Judge and Member Addl. MACT, Belagavi and C/c. VIII Addl. Dist. & Sessions Judge and Member Addl.

MACT, Belagavi, in presence of Sri. M.H.Nandagaon, Advocate for the petitioners, Sri. V.N.Sawant, Advocate for the respondent No.1, Sri.M.D.Tigadi, Advocate for the respondent No.2 and Sri.B.N.Chougala, Advocate for the respondent No.3.

It is ordered and awarded that:

The petition filed by the petitioners under Section 166 of the Motor vehicles Act is allowed in part with costs.

The petitioner No.1 and 4 are entitled compensation of Rs.22,14,600/- with interest at 6% p.a. from the date of petition till the date of its realisation.

The respondents No.1 and 3 are jointly and severally liable to pay the said compensation to the petitioners.

The petition of petitioner No.2 and 3 is hereby rejected.

The respondent No.3 is hereby directed to deposit the said compensation amount along with interest within three months from the date of award.

The petitioner Nos.1 and 4 are entitle compensation at the ratio of 60:40.

After deposit of compensation amount;

Among the shares of petitioners No.1 and 4 release 70% after proper identification and deposit 30% of amount

in any nationalized or schedule bank in their respective names for a period of three years.

Advocate fee is fixed at Rs.1,000/-.
