C H A R G E

I, **Latha J**, Prl. Civil Judge & JMFC, Magadi, do hereby charge you, as follows;

Firstly, that on 21-12-2017 at 10:30 a.m., in Sy.No.98/1, 98/2, Belagumba Village, Kasaba Hobli, Magadi Taluk within the limits of Magadi Police Station, in prosecution of common object, accused No.1 to 6, formed a members of an unlawful assembly, assembled together with an intention to commit certain offences and thereby you being the accused committed an offence punishable U/Sec.143 R/w Sec.149 of Indian Penal Code and within my cognizance.

Secondly, that on the above said date, time and place, you accused No.1 to 6, in prosecution of common object, formed an unlawful assembly, in prosecution of common object of the said assembly committed an act of rioting with intent to commit certain offence and thereby you being the accused committed an offence punishable U/Sec.147 R/w Sec.149 of Indian Penal Code and within my cognizance.

Thirdly, that on the above said date, time and place, in prosecution of common object of the said assembly was to commit rioting, to cause hurt, intentionally insult, criminal intimidation to C.W.1 and others and at that time you accused No.1 were armed with deadly weapons like wooden Stick, Rod, and thereby you being the accused have committed an offence punishable U/Sec.148 R/w Sec.149 of Indian Penal Code and within my cognizance.

Fourthly, that on the above said date, time and place, in prosecution of common object, you accused No.1 to 6 picked up quarrel with the C.W.2 to 4 and you accused persons voluntarily

assaulted C.W.2 to 4 by pulling with hands on and caused internal injury on body and thereby you being the accused have committed an offence punishable U/Sec.323 R/w Sec.149 of Indian Penal Code and within my cognizance.

Fifthly, that on the above said date, time and place, you accused No.1 to 6, formed an unlawful assembly in prosecution common object, you being the accused No.1 to 6 committed criminal trespass by entering into crusher place belonging to the informant and intention to commit certain offences and thereby you being the accused committed an offence punishable U/Sec.447 R/w Sec.149 of Indian Penal Code and within my cognizance.

Sixthly, that on above said date, time and place, in prosecution common object, you being the accused No.1 to 6, trespassed into the place of crusher of CW.1, you being the accused No.1, 3 4 broken the glass of compress bearing No. TN-25-X-4023 through rod and wooden stick and left the air on tire of lorry bearing no. KA-19-C-3010 and break the headlight of compressor and you being the accused No.1 damaged pump house and causing damage to the amount of Rs.50,000/- and thereby you being the accused committed an offence punishable U/Sec.427 R/w Sec. 149 of Indian Penal Code and within my cognizance.

Seventhly, that on above said date, time and place, in prosecution common object, you being the accused No.1 to 6 abused CW.1 to 4 in filthy language and thereby gave provocation to them intending or knowing it likely that such provocation will cause them to break the public peace or to commit any other offence and thereby you

being the accused committed an offence punishable U/Sec.504 R/w Sec.149 of Indian Penal Code and within my cognizance.

Finally, that on above said date, time and place, you accused No. 1 to 6 in prosecution of common object, you being the accused No.1 to 6 criminally intimidated C.W.1 to 4 by threatening to take away his life, so as to cause alarm in their mind and thereby you being the accused committed an offence punishable U/Sec.506 R/w Sec.149 of Indian Penal Code and within my cognizance.

And I hereby direct that you be tried on the said charge.
