C H A R G E

*I, **Smt.Dhanalakshmi.M**, Addl. Civil Judge & JMFC, Magadi, do hereby charge you, as follows;*

Firstly, that on 05.04.2018 at 10.30 p.m., in Thippasandra Hobli, Beechanahalli Village, within the limits of Kudur Police Station, near C.W.1's house, in prosecution of common object, you accused No.1 to 6 formed an unlawful assembly and thereby you Accused committed an offence punishable U/Sec.143 R/w Sec.149 of Indian Penal Code and within my cognizance.

Secondly, that on the above said date, time and place, you accused No.1 to 6 formed an unlawful assembly in prosecution common object, , you accused No.1 to 6 committed criminal trespass by entering into the house, which is belonging to the C.W.1 with an intention to commit certain offences and thereby you Accused committed an offence punishable U/Sec.448 R/w Sec.149 of Indian Penal Code and within my cognizance.

Thirdly, that on the above said date, time and place, you accused No.1 to 6 formed an unlawful assembly in prosecution common object, you accused No.1 assaulted C.W.1 with club

on his right hand, accused No.2 took club from accused No.1's hand and assaulted C.W.1 on his head and accused No.3 took club from accused No.2's hand and assaulted C.W.1 on his back and neck and thereby you accused committed an offence punishable U/Sec.324 R/w Sec.149 of Indian Penal Code and within my cognizance.

Fourthly, you accused No.1 to 6 formed a members of an unlawful assembly, you accused No.4, 5 and 6 assaulted C.W.1 with hands on his body and thereby you accused have committed an offence punishable U/Sec.323 R/w Sec.149 of Indian Penal Code and within my cognizance.

Finally, that on the above said date, time and place, you accused No.1 to 6 formed an unlawful assembly in prosecution common object, you accused No.1 to 6 criminally intimidated C.W.1 by threatening to take away his life, so as to cause alarm in his mind and thereby you accused have committed an offence punishable U/Sec.506 R/w Sec.149 of Indian Penal Code and within my cognizance.

And I hereby direct that you be tried on the said charge.
