CHARGE

I, **Mahesh B.T.**, B.Com, LL.M., Prl. Civil Judge & JMFC, Magadi do hereby charge you;

- : 1. Linganna S/o late Muradappa,
Aged about 70 years.
2. Rajashekaraiah S/o Linganna,
Aged about 40 years.
- A1 & A2 Both are R/at
Byranahalli, Kasaba Hobli,
Magadi Taluk.
3. Kumara S/o late Revanna,
Aged about 55 years.
R/at Kalari Village, Kasaba Hobli,
Magadi Taluk.

R/at Aralakuppe Village, Madabal Hobli,
Magadi Taluk.

As follows:

That, on 16-05-2021 Near land bearing Sy.No.183, near Satanur Village, Bairanahalli, Kasaba Hobli, Magadi Taluk, you accused No.1 to 3 in furtherance of the common intention, voluntarily caused bodily pain to CW-1 to 3 by assaulting on them by hands and thereby committed an offence punishable under Section 323 read with Section 34 of I.P.C; and

Secondly, on the above said date, time and place you accused No.1 to 4 in furtherance of the common intention, of you Accused No.2 voluntarily assault by sickle and thereby committed an offence punishable under Section 326 read with Section 34 of I.P.C.

Thirdly, that on the above said date, time and place, in prosecution of common intention, you accused No.3 assaulted CW-6 with stick, knowing fully well that the above said object is used as a weapon of offence likely to cause death and caused grievous injuries and thereby you accused have committed an offence punishable U/Sec.324 R/w Sec.34 of Indian Penal Code;

Fourthly, on the above said date, time and place you accused No.1 to 4 in furtherance of your common object, intentionally insulted CW-1 to 3 by abusing them, in filthy language and thereby gave provocation to them to break the public peace and thereby committed an offence punishable under Section 504 r/w Section 34 of I.P.C;

Lastly, on the above said date, time and place, you accused No.1 to 4 in furtherance of common intention, you accused no.1 to 3 committed criminal intimidation by threatening CW-1 to 3 to do away their life and thereby committed an offence punishable under Section 506 r/w Sec.34 of I.P.C.

The above said offences are within my cognizance and I hereby direct that you be tried by me on the above said charges.
