CHARGE

**I, Shrinivasa K. R., B.Sc., LL.B., LL.M., Prl. Civil Judge
& JMFC, Magadi, do hereby charge you:**

It is alleged against you accused no.1 to 6 that on 16-05-2021 at about 11:00 a.m. in the land at Sy.No.183, at Byranahalli Village, Kasaba Hobli, Magadi formed an unlawful assembly with a common object to commit an offence and thereby committed an offence punishable U/Sec.143 R/W. Sec.149 of Indian Penal Code and within my cognizance.

That on the above said date, time and place, in prosecution of common object, you accused No.1 to 6 by forming an unlawful assembly to commit an offence, committed rioting and thereby committed an offence punishable under Sec.147 R/W. Sec.149 of IPC and within my cognizance.

That on the above said date, time and place, in prosecution of common object, you accused No.1 to 6 by forming an unlawful assembly to commit an offence, voluntarily assaulted CW-1, 4, 5 & 6 with hands and legs and caused simple injury and thereby committed an offence punishable under Sec.323 R/W. Sec.149 of IPC and within my cognizance.

That on the above said date, time and place, in prosecution of common object, you accused No.1 to 6 by forming an unlawful assembly to commit an offence, intentionally insulted CW-1, 4 to 6 and thereby gave provocation will cause CW-1, 4 to 6 to break public peace and thereby you accused committed an offence punishable U/Sec.504 R/W. Sec.149 of IPC and within my cognizance.

That on the above said date, time and place, in prosecution of common object, you accused No.1 to 6 by forming an unlawful assembly to commit an offence, criminally intimidated CW.1, 4 to 6 by threatening them that they will kill them with an intent to cause alarm in them and thereby you accused committed an offence punishable U/Sec.506 R/W. Sec.149 of IPC and within my cognizance.

And I hereby direct that you be tried on the said charge..
