01. Perused the application and say filed. Heard Ld.Adv. Shri.K.D.Walujkar for applicant and Ld.A.G.P Shri. D.D.Deshmukh for State. Also perused the original Smart Card.

02. Perusal of say filed by I.O. indicates that the Venue 1 5 CREDI MT SX of Hundai Motor India Ltd. four wheeler vehicle bearing registration No.MH-45-AL-5011 is seized by investigating officer in connection with C.R. No.201/2026 registered with Kurduwadi Police-station. The say further revealed that the said Venue four wheeler vehicle is not required for further investigation. Original Smart Card revealed that the application is registered owner of the said Venue four wheeler vehicle. Admittedly, the said Venue four wheeler vehicle is lying abundant at police-station. Therefore, considering the maintenance of said vehicle it is just and proper to pass the following order.

ORDER

(1) The application is hereby allowed.

(2) The investigating officer is hereby directed to hand over the interim custody of Venue four wheeler vehicle bearing registration No.MH-45-AL-5011 in connection with C.R. No.201/2026

registered with Kurduwadi Police-station seized by him to the applicant, on his execution of indemnity bond worth of Rs.8,00,000/-subject to following conditions.

(A) The applicant/accused is directed not to change the nature of said Venue vehicle, not to create third party interest either by way of sale, mortgage etc. till the conclusion of trial.

(B) Applicant/accused is further directed to produce the said Venue four wheeler vehicle before the Court as and when called by the Court during trial.

(C) I.O. is directed to execute the panchnama and took photographs of said Venue four wheeler vehicle at the time of its return to the applicant and said papers be submitted along with charge-sheet.

(D) Breach of conditions will result into automatic cancellation of interim custody of said Scorpio vehicle.

(E) Inform concerned, accordingly.
