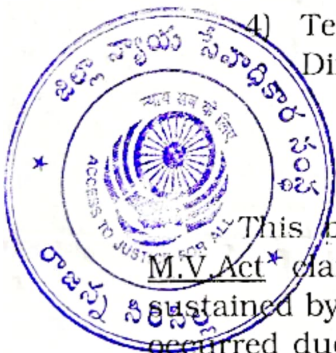

This petition dt:21-12-2022 filed by the petitioner U/sec.166 (1) (a) of M.V.Act claiming compensation of Rs.5,00,000=00 on account of injuries sustained by Bukya Saritha @ Azmeera Saritha in a motor vehicle accident which occurred due to rash and negligent driving of driver of the Hire Bus bearing No. TS-02-UB-1051, that took place on 02.09.2022 at 14:00 hrs at Near H.P.Petrol Bunk, Chandrampet village of Sircilla mandal.

Value for the purpose of the court fee and jurisdiction is Rs.5,00,000=00 and court fees of Rs.4,360=00 is paid U/Sec.475 (1) (b) of A.P.M.V. Rules.

This petition was referred to the Lok Adalat at the request of the both

parties on the memo filed by Advocate for petitioners and Advocate for the respondent Nos. 3 by the Motor accident Claim Tribunal cum I-Addl. District and Sessions Judge, Rajanna Sircilla.

This petition is coming on for final settlement in the presence of petitioner and the respondents and **Sri V. Ramana Reddy**, Advocate for the petitioner and **Sri Sayed Hasanuddin Chisty**, Advocate for respondent No.3. Both parties have agreed for amicable settlement. Hence, the following Award is passed as per the settlement arrived by the parties.

AWARD

1. Compensation of Rs.2,20,000=00 (Rupees Two Lakhs Twenty Thousand only) is awarded to the petitioner against Respondent No.3.
2. That the petitioner is awarded an amount of Rs.2,20,000=00 (Rupees Two Lakhs Twenty Thousand only) and permitted to withdraw her entire amount, soon after deposit by the Respondent No.3/Insurance company.
3. If Respondent No.3/Insurance company does not deposit the above amount within 2 months from today, the amount so awarded shall carry interest @7.5% per annum.
4. The Court Fee of Rs.4,360/- shall be refunded U/sec.21(1) r/w Section 25 of the Legal Services Act, 1987.
5. Advocate Fee is not fixed.

Both parties have signed/affixed their signatures in evidence of their consent for the terms of Award.
