as follows;

The CW.14 is having provision shop situated at Kerehalli cross of Ripponpete, Shivamogga road and on 10.09.2019 at 6.45 p.m. in front of the said shop, on the instigation of you accused No.1, other accused No.2 to accused No.4 in furtherance of common intention having knives in their custody and with an intention to murder CW.1 and CW.10 with preplan caught hold of the CW.1 and CW.10 who were not able to escape and pushed them down and you accused No.1 caught hold of CW.1 and told him "How dare you have warned me" and abused him in filthy language and assaulted CW.1 with knife on his neck part and when CW.1 attempted to escape you accused No.1 assaulted him on his chest part and he has sustained bleeding injury meanwhile you accused No.2 caught hold of the CW.10 with an intention to murder him and assaulted him with knife on his stomach and near left rib back and made him to suffer bleeding injury and you accused No.1 and accused No.2 attempted to commit murder of CW.1 and CW.10 and thereby you accused No.1 and 2 have committed an offence punishable U/Sec.307 R/W/Sec.34 IPC and within my cognizance.

That on the aforesaid date, time and place in the course of same transaction, you accused No.3 and 4 kicked the CW.1 and CW.10 with legs and caused injuries to them and you accused No.3

and accused No.4 voluntarily caused hurt to CW.1 and CW.10 and thereby you accused No.3 and accused No.4 have committed an offence punishable U/Sec.323 R/W Sec.34 IPC and within my cognizance.

And, I hereby direct that you be tried by me on the said Charges.
