Examination in chief by the Public Prosecutor.

From 2016 till 2025, I worked in various capacities at RFSL, Davanagere.

2. On 25-03-2022, our Office received 4 sealed articles from Shashidhara K.N. - PC 1021 of Soraba Police station, pertaining to Crime No. 31/2022. Our reception section received the said articles and the same was registered as RFSL/BS/170/2022. The said articles were sent to biological section for chemical analysis and for issuance of report. I have received the said articles and scrutinized the seal over the said articles and the same were intact and tallied with the sample seal.

3. After opening the said four sealed articles, I found the following.

- a. One Iron Machu
- b. One hat
- c. One shirt
- d. One shirt

4. I subjected the said articles for chemical analysis and microscopic examination. After examination of the said articles, I issued report stating that Items No. 1 to 4 were stained with human blood and Item No.1 and 4 were stained with 'O' group blood and item No. 2 and 3 were stained with 'B' group blood.

5. Now, I see the said report issued by me and the same is marked as Ex.P.9 and the witness signature is marked as Ex.P.9(a) and (b).

6. After examining the articles, I repacked the same, sealed it and forwarded the same to the police along with the sample seal of our Laboratory. Now I see the sample seal issued by me and the same is marked as Ex.P.10 and the witness signature is marked as Ex.P.10(a).

7. Now, I see the four articles examined by me and same are already marked as MO 1 to MO4.

Cross examination by Sri. EN, Advocate for accused No. 1 and 2 :

8. It is true to suggest that I have not mentioned the date of examination of articles in my report. It is true to suggest that I have not mentioned that Machu is having wooden handle in my report. It is true that Item No. 4 is blue colour half sleeve shirt. It is true that Item No.2 is hat and Item No.3 is full sleeve shirt. It is true to suggest that I have not mentioned the RH factor of the O group blood in my report. Witness volunteers that the Investigation Officer had not asked about the RH factor of the blood groups, hence, I have not mentioned the same in my report. It is false to suggest that since I have not examined the articles sent by the I.O., I have not mentioned the date of examination of the articles in my report. It is false to suggest that I have issued false report at the instance of Investigation Officer.
