as follows;

That on 09-06-2019 at 7-30 p.m. when CW.1 and CW.2 were coming infront of Hunasekoppa Manjunath's house tar road, you accused No.1 to 9 within the limits of Soraba police station by forming an unlawful assembly by holding dangers weapons like stone, club have wrongfully restrained Cws.1 and 2 with a common object of committing murder and thereby you accused No.1 to 9 have committed an offence punishable U/Sec.143, 147, 148, 341 r/w/Sec.149 of IPC and within my cognizance.

That on the above said date, time and place, in furtherance of common object of such assembly, you accused No.1 to 9 abused Cw.1 and Cw.2 with filthy language and gave provocation to them intending or knowing to be likely that such provocation will cause them break public peace or to commit any other offence and thereby you accused No.1 to 9 have committed an offence punishable U/Sec.504 r/w/Sec.149 IPC and within my cognizance.

That on the above said date, time and place, in furtherance of common object of such assembly you accused No.1 to 9 have assaulted CW.2 with your hands all over his body and made him to suffer and made him to suffer simple injuries and thereby you accused No.1 to 9 have committed an offence punishable U/Sec.323 r/w/Sec.149 of IPC and within my cognizance.

That on the above said date, time and place, in furtherance of common object of such assembly, you accused No.3 assaulted CW.2 with stone kept in your hand on the head and all over his body

forcefully and made into fall down who suffered grievous injuries and accused No.4 caught hold of hands of CW.1, then accused No.6 assaulted CW.1 with club and made him to fall down then you accused No.7 assaulted CW.1 with stone and made him to suffer grievous injury and thereby you accused No.3,4,6 and 7 along with other accused persons have committed an offence punishable U/Sec.326 r/w/Sec.149 of IPC and within my cognizance.

That on the above said date, time and place, in furtherance of common object of such assembly, you accused No. 1 to 9 with a common intention to murder Cw.1 and Cw.2 have assaulted them with stone and club on their head and all over their bodies and you have done the aforesaid act with such intention and with knowledge and under such circumstances you would have caused the death of CW.1 and CW.2 and you would have been guilty of murder and thereby you accused No.1 to 9 have committed an offence punishable U/Sec.307 r/w/Sec.149 of IPC and within my cognizance.

That on the above said date, time and place, in furtherance of common object of such assembly, you accused No.1 to 9 being in furtherance of common object have abused the Cw.1 and Cw.2 with filthy language and you have criminally intimidated Cw.1 and Cw.2 threatening them with dire consequences of their life and thereby you accused No.1 to 9 have committed an offence punishable U/Sec.506 r/w/Sec.149 of IPC and within my cognizance.

And, I hereby direct that you be tried by me on the said Charges.
