CHARGE

I, **Sri Ravindra R, B.A.L., LL.M.**, V Addl. District & Sessions Judge, Shivamogga, sitting at Sagar, do hereby charge you;

- 1) Shivappa
S/o Veerabasappa
Aged about 60 years,
R/at Gangolli village,
Soraba Taluk,
Shivamogga District,
Karnataka.
- 2) Parameshwarappa
S/o Channabasappa,
Aged about 58 years,
R/at Gangolli village,
Soraba Taluk,
Shivamogga District,
Karnataka.

as follows:

Firstly, CW.6 Sujatha was residing along with her two minor children at Chikkeruru village, Hirekeruru Taluk, Haveri District. The husband of CW.6 has expired. The deceased Ramesh used to visit the house of CW.6 and harass her. CW.6 had informed about

the said harassment to you accused no.1 and 2. Hence, you accused no.1 and 2 went to the house of deceased Ramesh situated at Gangolli village, Soraba Taluk and threatened him with dire consequences, if he again visit the house of CW.6 and harass her. On 18.06.2020, at about 9.00 p.m., the deceased Ramesh, standing in front of his house, was abusing you accused no.1 and 2 by using filthy words. After coming to know about the said fact, you accused no.1 and 2 went near the house of deceased Ramesh and picked up a fight with him and abused him by using filthy words as (ಸೂಳೆಮಗನೆ, ಮಿಂಡಿಮಗನೆ). Thereby you accused no.1 and 2 committed an offence punishable U/Sec.504 r/w/Sec.34 of IPC and within the cognizance of this Court.

Secondly, that on the above said date, time and place, you accused no.1 and 2 decided to commit the murder of deceased Ramesh, assaulted him with your hands. Further, you accused no.1 and 2 dragged the deceased Ramesh near the coconut tree situated in front of the house of Basavarajappa of Gangolli village and tied him to the coconut tree tightly by using rope and committed the murder of the deceased-Ramesh. Thereby you accused no.1 and 2 committed an offence punishable U/Sec.302 r/w/Sec.34 of IPC and within the cognizance of this Court.

Lastly, that on the above said date and time, you accused no.1 and 2, after committing the murder of deceased Ramesh, brought the dead body of Ramesh, from the said place as stated in secondly

and kept the dead body of Ramesh in front of his house. Thereby you accused no.1 and 2 committed an offence punishable U/sec. 201 r/w/Sec.34 of IPC and within the cognizance of this Court.

And, I hereby direct that you shall be tried by this Court for the above said charge.
