you the accused;

1. Syed Eliyaz,
S/o Late Syed Sadiq,
Aged about 26 years, Labourer,
R/o, Hullenahalli Gate,
Rajivgandhinagara, Gulur Hobli,
Tumakuru Taluk, Tumakuru.
2. Shabaz Khan S/o Abeebulla Khan,
Aged about 28 years, Labourer,
R/o, Hullenahalli Gate,
Rajivgandhinagara, Gulur Hobli,
Tumakuru Taluk, Tumakuru.
3. Syed Waseem S/o Syed Shameer,
Aged about 24 years, Labourer,
R/o, Kothamaranahalli, Gulur Hobli,
Tumakuru Taluk, Tumakuru.
4. Pavan Yadav S/o Sadashivaiah,
Aged about 28 years, Farmer,
R/o, Godekere Gollarahatti,

As follows:-

That on 30/06/2021 at about 5-45 p.m., near Bus stop, Hullenahalli Gate, Gulur Hobli, Tumakuru Taluk within the jurisdiction of Hebbur P.S., you accused No.1 to 3 were found in conscious possession of ganja weighing 250 Grams and said ganja was received by you accused No.1 to 3 from you accused No.5 and you accused No.5 had received said ganja from you accused No.4 and you accused No.4 had received said ganja from absconded accused No.6 and said ganja is small quantity and you accused No.1 to 3 possessed it with an intention to sell the same for your wrongful gain without having valid license or permit and thereby you accused No.1 to 5 have committed the offence punishable U/S.20(b)(ii)(A) of the Narcotic Drugs and Psychotropic Substances Act, 1985 and within the cognizance of this Court.



That on 01/07/2021 at about 12-00 p.m., in the house of you accused No.5 situated near Isra Shadi Mahal, 4th Cross, Nazarabad, Tumakuru, you accused No.5 along with absconded accused No.6 found in conscious possession of 7 KGs. 002 Grams of ganja and said ganja is more than small quantity and less than commercial quantity i.e., intermediate quantity and you possessed it in your house with an intention to sell the same for your wrongful gain without having valid license or permit and you accused No.1 to 4 in collusion with accused No.5 along with absconded accused No.6 are also involved in possessing said Ganja and thereby you accused No.1 to 5 have committed the offence punishable U/S.20(b)(ii)(B) of the Narcotic Drugs and Psychotropic Substances Act, 1985 and within the cognizance of this Court.

That on 01/07/2021, in the farm house of grandmother of you accused No.4 by name Late Ningamma situated at Sy.No.57/2 of Sondenahalli Village, you accused No.4 found storing of 34 KGs. 724 Grams of ganja and said ganja is commercial quantity and you possessed it in your farm house belonged to your grandmother with an intention to sell the



same for your wrongful gain without having valid license or permit and you accused No.1 to 3 & 5 along with absconded accused No.6 in collusion with accused No.4 are also involved in possessing said Ganja and thereby you accused No.4 has committed the offence punishable U/S.20(b)(ii)(C) of the Narcotic Drugs and Psychotropic Substances Act, 1985 and within the cognizance of this Court.

That you accused No.4, being the owner of Honda Activa Two-wheeler bearing Reg.No.KA-44-S-4232 knowingly used the said vehicle for transportation of ganja and thereby you accused No.4 committed the offence punishable U/S.U/S.20(b)(ii)(C) R/W S.25 of the Narcotic Drugs and Psychotropic Substances Act, 1985 and within the cognizance of this Court.

And I hereby direct that you be tried on the above said charges.
