**I, H.S.Mallikarjunaswamy, B.Sc., LL.B. C/c III Addl.
Sessions Judge, Tumkur, hereby charge you:**

1. L.P. Umadevi @ Uma
W/o T.N.Mahadevaiah,
Aged about 45 years.
 2. T.N.Mahadevaiah S/o late Nanjappa,
Aged about 60 years.
 3. Chethan S/o T.N.Mahadevaiah,
Aged about 25 years.
 4. Nandan @ Nanda
S/o T.N.Mahadevaiah,
Aged about 22 years.
- A1 to 4 are r/o B.C.Kaval village,
Dandinashivara hobli, Turuvekere Taluk.
5. Prakasha S/o Late Lingappa,
Aged about 45 years,
r/o Sampige Hosur village,
Dandinashivara hobli, Turuvekere taluk.

as follows:-

That on 05.09.2013 at about 9.30 a.m. in the land bearing Sy.No.158 situated at B.C.Kaval village, Dandinashivara hobli, Turuvekere taluk, when CW2 tilling the land along with CW's 1, 3 and 4. At that time, A2 came there and abused CW1 and 2 in filthy language like “ಮಾದಿಗ

ನನ್ನ ಮಕ್ಕಳಾ, ಮಾದಿಗ ಸೊಳೇ ಮುಂಡೆ, ನೀನು ಯಾವಳೇ, ಯಾರ ಅಪ್ಪನ ಜಮೀನು

ಎಂದು ಬಂದಿದ್ದೀಯಾ, ಮಾಡಿಗಿತ್ತಿ ಮುಂಡೆ” and thereby gave provocation to them intending that such provocation will cause them to break the public peace and thereby committed an offence punishable u/s 504 r/w 149 of IPC and within the cognizance of this court.

Secondly, on the above said date, time and place you A2 assaulted CW2 on his back with coconut Yademotte, when CW1 tried to rescue CW2, A1 holding her hairs and dragged her and assaulted on her left cheek with his hands and voluntarily caused hurt to CW1 and thereby committed an offence punishable u/s 323 r/w 149 of IPC and within the cognizance of this court.

Thirdly, on the above said date, time and place you A2 assaulted CW1 on her stomach by using chappals to dishonour CW1 otherwise than on grave and sudden provocation given by CW1 and thereby committed an offence punishable u/s 355 r/w 149 of IPC and within the cognizance of the court.

Fourthly, on the above said date, time and place you A3 kicked CW2 on his left side chest with his legs, A4 kicked CW2 near his left side ribs and voluntarily caused injury to CW2 and thereby committed an offence punishable u/s 324 r/w 149 of IPC and within the cognizance of the court.

Fifthly, on the above said date, time and place you A1 to 5 committed criminal intimidation by threatening the life of CW's 1 and 2 and thereby committed an offence punishable u/s 506 r/w 149 of IPC and within the cognizance of this court.

Lastly, on the said date, time and place, you accused, not being the members of scheduled caste or scheduled tribe, intentionally insulted CW.1 and 2 who belonged to Scheduled caste, by using words “ಮಾದಿಗ ನನ್ನ ಮಕ್ಕಳಾ, ಮಾದಿಗ ಸೂಳೇ ಮುಂಡೆ, ನೀನು ಯಾವಳೇ, ಯಾರ ಅಪ್ಪನ ಜಮೀನು ಎಂದು ಬಂದಿದ್ದೀಯಾ, ಮಾದಿಗಿತ್ತಿ ಮುಂಡೆ” with intent to dishonour and humiliate him in a public view and thereby committed an offence punishable u/sec. 3cl.(1)(x)(xi) of SC/ST (PoA) Act and within the cognizance of this court.

And I hereby direct that you be tried by this court on the above said charges.
