EXAMINATION IN CHIEF BY PUBLIC PROSECUTOR:

1. Since 2019, I have been working as Scientific Officer in Questioned Documents Section at FSL,Bengaluru. I did M.Sc. Forensic Science and I did Ph.D. in Forensic Science. I have undergone 2 years in house training in questioned documents. I have attended several workshops. I have



examined questioned documents in 500 cases and I gave evidence in 20 cases.

2. On 10.08.2022, our laboratory received two documents sent in Cr.No.176/2022 of Gubbi police station through PC Jaganaik of Gubbi police station. The seals found on the documents were intact and tallied with sample seal. The description found on the documents correspond to that of those present in the invoice.
3. The documents examined by me are standard handwriting of deceased marked as No.2 by the I.O. and handwriting of deceased note book PREMIUM USHA GOLD-WORLD CAR FREE DAY SEPTEMBER 22 KING SIZE NOTE BOOK-marked as No.1 by the I.O.
4. 1.Questioned writings in the enclosed portion in one King Size notebook labelled as 'My USHA GOLD-WORLD CAR FREE DAY SEPTEMBER 22(138 pages)' in page No.70 marked as QW-1 by the I.O. and admitted writings in the enclosed portion said to be of Kavyashree in four pages in a King Size notebook labelled as 'Paper Soft Inspiring You For The Future (66 pages)' in page No.28, 29, 32 and 34 marked as DSW-1 to DSW-4 by the I.O.
5. On examination, I gave my opinion as the person who wrote the admitted writings marked as DSW-1 to DSW-4 also wrote the questioned writings marked as QW-1. I this



regard, I have issued report. Same is marked as Ex.P17. Sample seal is marked as Ex.P18 and my signature is marked as Ex.P18(a). Now I see the documents examined by me and they are already marked as Ex.P6 and 7.

Cross examination by for H.M.Gurunanjegowda, advocate for accused :

6. It is not true to suggest that I have not received any articles for examination by the police and I have not examined those articles. It is not true to suggest that I have given false report.
