Petition u/s.497 BNSS is filed to handover the R.C book of the vehicle Bharath Benz Tipper Lorry bearing Registration No.TN 92 E 4593 to the petitioner / owner of the vehicle for one month to get F.C.

This Petition has come up for final hearing before this court today, in the presence of Thiru.T.K.Jestin Marshall, Advocate for the petitioner and in the presence of the learned Public Prosecutor for prosecution.

Heard both side. Upon perusal of available records before this court and on consideration of oral representations made by both side, this court delivered the following:

ORDER

The learned Counsel for the petitioner has submitted that, the Tipper Lorry bearing Registration No.TN92E 4593 which belongs to the petitioner was seized by the respondent police in Crime No.207/2022 and subsequently based on the Order passed by this Court in Cr.M.P. No.3592/2022 dated 19.07.2022, the interim custody of the vehicle was handed over to the petitioner and the petitioner has already submitted the original R.C book before the Judicial Magistrate Court, Tiruchendur and that now, the R.C. book of the above vehicle is required to be submitted before RTO for renewal of Fitness Certificate and that therefore, the original R.C. book has to be handed over to the petitioner for temporary custody of one month.

However, the learned Public Prosecutor has not raised any serious objection for granting temporary custody of the R.C. book of the said vehicle to the petitioner.

Considering the facts that the Tipper Lorry bearing Registration No.TN92E 4593 has already been handed over to the petitioner / owner of the vehicle for temporary custody and that the Original R.C. book of the above vehicle is kept with the Judicial Magistrate Court, Tiruchendur and that the original R.C. book is required for the petitioner / owner of the vehicle for renewal of Fitness Certificate, this Court is of the opinion that the Original R.C. book of the above vehicle may be handed over to the petitioner for temporary custody for a period of one month on certain conditions.

In the result, this petition is allowed and the R.C. book of the tipper Lorry bearing Registration No.TN92E 4593 kept in the custody of learned Judicial Magistrate, Tiruchendur is ordered to be handed over to the petitioner for a period of one month from the date of this order (from 25.03.2026 to 24.04.2026) with

conditions that the petitioner has to file undertaking affidavit stating that the petitioner will not use the R.C. book for any other purpose or any other illegal activities and the petitioner shall produce the R.C. book within the above stipulated time before the aforesaid Court on executing a bond for a sum of Rs.10,000/-.
