ORDER

This case was charge sheeted by the Sub Inspector of Police, Medical College Police Station for offences punishable u/ss.283, 506, 294(b), r/w 34 IPC and Sec 2(1)(b) V, 3(a)(1)(i) of Kerala Health Care service Persons and Health care Service Institutions Amendment Act.

2. Prosecution case is that on 13-06-2024 at about 01:00 Hrs, when the defacto complainant and his younger brother were taken to Medical College Hospital from Beach Hospital for treatment, the accused obstructed their vehicle by using another vehicle bearing Reg. No KL 11 BQ

9097 and near the Casualty of Medical College Hospital, beaten the defacto complainant and his brother with hands after wrongfully restraining them and uttered obscene words to the defacto complainant and his younger brother and criminally intimidated to kill them. Thus the accused committed the above offences.

3. On appearance of accused No. 1 and 2, copies of relevant records were furnished to them . They were released on bail. All the documents verified and found correct.

4. On perusal of records, it appears that the offence alleged against the accused is exclusively triable by a Court of Sessions. Hence, the case against A1 and A2 committed to the Hon'ble Court of Sessions, Kozhikode u/s.209 of Cr.P.C., for trial.

5. Transmit the case records and properties, if any, to the Hon'ble Court of Sessions, Kozhikode. The accused is directed to appear before the Hon'ble Court of Sessions, Kozhikode as and when directed. Issue notice to the Public Prosecutor, Kozhikode regarding the factum of committal of the case.
