2. Whether the plaintiff proves that plaintiff and defendants being the co-parceners are in joint possession and enjoyment of the suit schedule properties?
3. Whether the plaintiff proves that 1<sup>st</sup> defendant being senior male member of the joint family managing the suit schedule properties, hence

most of the suit schedule properties standing in his name?

4. Whether the plaintiff proves that 1<sup>st</sup> defendant had acquired 4 items of suit schedule properties in his name and also in the name of his wife out of joint family funds and nucleus?
5. Whether the plaintiff proves that he is having 1/4th share in the suit schedule properties?
6. Whether the plaintiff is entitled for the reliefs as sought for in the plaint?
7. Whether the defendant No.1 proves that on 31.12.1976 the sons of Venkategowda and sons of Giryappa got divided their ancestral and joint family properties under panchayath palupatti, in which the suit schedule item No.1,2, 5 to 16 and 17 has fallen to the share of I.V. 10. Whether the defendant No.1 proves that after the death of Giryappa, I.V. Venkategowda, Venkataramu and Gangadoddamma and defendant No.1 and his mother Thimmavva have got divided their ancestral and joint family properties under panchayath palupatti dated 23.03.1997?
11. Whether the defendant No.1 proves that in the palupatti dated 23.03.1997 the suit item No.13,
