Order No. 11 Dated 15.06.2026 :

Today is fixed for production of both the accused persons and hearing of the bail application of the accused **Sahajaman Mondal @ Sahabaj Mondal and Rakhibul Mondal @ Piti @ Akherul Mondal**.

Accused **Sahajaman Mondal @ Sahabaj Mondal and Rakhibul Mondal @ Piti @ Akherul Mondal** are produced before the Court through VC.

Another accused namely **Hanef Mondal** is produced before the Court on the strength of W/A.

Ld. Advocate for the accused persons namely **Sahajaman Mondal @ Sahabaj Mondal, Rakhibul Mondal @ Piti @ Akherul Mondal and Hanef Mondal** had filed a petition praying for bail.

Ld. Special P.P. (POCSO) is appeared for the State.

Copy served.

Heard the Ld. Advocate of both sides.

Ld. Advocate for the accused persons submitted that the accused **Rakhibul Mondal @ Piti @ Akherul Mondal** is in custody from 30.12.2025 and accused **Sahajaman Mondal @ Sahabaj Mondal** had surrendered before this Court on 22.05.2026 and since then, they have been languishing in custody and, as such, further detention of the accused persons are not necessary and all the allegations against the said accused persons are completely false and fabricated story. He further submitted that today another accused namely **Hanef Mondal** is produced before this Court on the strength of warrant of arrest issued by this Court on the previous occasion. He further submitted that charge-sheet of this case has already been submitted U/Sec. 6 of POCSO Act against the

principal accused of this case. He further submitted that no application for bail is pending or rejected by the upper forum till date against the present accused person persons. He further submitted that the accused persons are having permanent residence within the jurisdiction of this Court and there is no chance of absconding the accused persons and they will face the trial and he prays for bail on any terms and conditions.

On the other hand, Ld. Special PP (POCSO) raised strong objection on the ground that there are sufficient materials in the CD against these accused persons and, as such, it is a fit case for custody trial.

De-facto complainant is present and stated before the Court that she has no objection against the bail application.

Perused the case record and the CD.

It appears from the case record that the charge-sheet of this case has already been submitted U/Sec. 6 of POCSO Act against the principal accused of this case after completion of investigation and the VG was aged about 14 years at the time of incident.

Considering the materials in the CD, submission of charge-sheet, the nature of offence, PM report, I am not inclined to enlarge the accused persons namely **Sahajaman Mondal @ Sahabaj Mondal and Rakhibul Mondal @ Piti @ Akherul Mondal** on bail. Accordingly, their bail prayer are **rejected**.

Considering the statement of the mother of the VG U/Sec. 183 BNSS and page no. 94 & 95 in the CD, it reflects that there is a family dispute in between both the parties and there is no materials against the accused **Hanef Mondal** to detain him in custody.

Accordingly, the accused namely **Hanef Mondal** may find AI bail of Rs. 4,000/-with two sureties of Rs. 2,000/-each, till next date subject to the satisfaction of the Ld. CJM, Krishnagar, Nadia i.d. to J/C till date.
