This PRC came on this day for hearing in the presence of learned A.P.P for the State and Sri **Md.Ubed**, Advocate for the Accused. Upon perusing material papers on record, upon hearing arguments and having stood over for consideration to this day the court made the following:-

COMMITTAL - ORDER

1. The Sub Inspector of Police, PS.I-Town, Mahabubnagar has filed charge-sheet against Accused in Cr.No.130/2025 for the offences U/Sec.109 BNS.
2. The prosecution case in brief is that on 03.05.2025 at 1400hours the complainant/Rasheed Khan lodged a complaint in which she stated that on 03.05.2025 at about 11:30hours accused was present at Medical shop and while he was proceeding to I-Town from his home, accused stopped him and requested to

consume Alcohol. Then both went to Thrishool wines shop and consumes alcohol, in the mean time accused forced complainant to bring excess alcohol to him, then he refused hi request due to insufficient money. On that accused got angry and picked up quarrel by saying “ NINNU IKKADE CHAMPUTHA” and cut off his throat indiscriminately with knife which was already possessed with him on that he sustained bleeding injuries and fell down in pool of blood on the spot. Therefore the owner of wines shop noticed the same and he was shifted to Government Hospital for treatment. Hence, complainant requested to take necessary action against the Accused.

Basing on the above complaint, LW15/M.A.Rasheed Sub Inspector of Police registered a case in Cr.No.130/2025, U/Sec.109 BNS and took up the investigation. After completion of investigation LW16/P.Seenaiah filed charge sheet against the accused.

During the course of investigation, LW15/M.A.Rasheed, Sub Inspector of Police, visited the Government hospital and there he examined and recorded the statement of LW1/Rasheed Khan, LW5/Nuzzath Shaheen and LW6/Munwar Khan. Thereafter LW15/M.A.Rasheed seized the light blue color pant having blood stains and white color lines shirt having blood stains from LW1/Complainant. Subsequently LW15/M.A.Rasheed visited the scene of offence and conducted scene of offence panchanama in the presence of LW9/Kommu Vamshi and LW10/Are Sai Krishna

and also recorded the statements of LW2/Banavat Rajesh, LW3/Shashi Kumar and LW4/Kurva Venkataiah at scene of offence.

On 09.05.2025, LW15/M.A.Rasheed, Sub Inspector of police served a notice U/sec.35(1)(b) BNSS to accused and directed him to appear before the Hon'ble Court after receiving of summons.

3. The court took cognizance of the offence punishable U/Sec.109 BNS against the Accused.

4. After production of the Accused, copies of documents were furnished to him according to section 230BNSS.

5. The offence punishable U/Sec.109 BNS is exclusively triable by the Court of Sessions. Hence, this case committed to the Hon'ble Court of Sessions Mahabubnagar as per section 232(a)BNSS.

6. The property was deposited in this court vide CPR.No.05/2026 and the same is transferring to the Hon'ble Court along with the commital order.

7. The Office is directed to notify the commitment of case to the Public Prosecutor, Hon'ble Court of Sessions, Mahabubnagar as per section 232(d)BNSS.

8. Accused stated that he got means to engage Advocate to defend him before the Hon'ble Court of Sessions Judge, Mahabubnagar.

9. Accused is directed to appear before the Hon'ble Court of Sessions, Mahabubnagar on **30.06.2026**.
