This bail application has been filed before this court through Online and this Petition is coming for final hearing on 12.08.2026 in the presence of Advocate R.Kalpana, for accused and Tmt.M.Seerin Sithara Sweetey, APP for the complainant and having stood for consideration to this day, the Court delivered the following:-

Order

1. This petition is filed U/s.480 of Bharathiya Nagarik Suraksha Sanhita seeking bail for the offence U/s. 308(4) BNS.

2. The Learner advocate appearing for the accused stated that, accused remanded to judicial custody on 20.07.2026 further states that he is innocent and he is falsely implicated in this case and he is only breadwinner of his family and he is law abiding citizen. He is ready to abide by the conditions imposed by this court and ready to substantial surieties. The Petitioner will not abscond or tamper witness and hence prays to grant bail.

3. The learned respondent police objected the application on the ground that if bail granted he may abscond and there is every chance to tamper prosecution witnesses and will do the same offence again. Hence, strongly opposed to release on bail .

4. The Petitioner/accused is in judicial custody for the past 24 days and on perusal of the records and on considering the submissions of both side. Though it is replied by the prosecution that considering above as well as facts & circumstances of this case. Hence this court inclined to grant bail to the petitioner/accused. In the result this petition is allowed, the Petitioner/accused is ordered to be released on bail on the following conditions.

i) The Petitioner/accused shall execute a bond for his personal appearance by producing two sureties, one family surety for a like sum of Rs.10,000/- each and petitioner shall produce identification proof to show his residential address.

ii) The petitioner/accused should appear and sign before the respondent police station daily at 10.00 A.M for 30 days.

iii) The petitioner shall not commit any offences of similar nature. The petitioner/accused directed to co-operate with the prosecution during the and trial proceedings and must not tamper any evidences or witnesses.
