being unable to procure the details. As such, the decree holder seeks execution of the decree by arrest and detention of the judgment debtor in civil prison.

4. Money decree can be executed by arrest and detention of judgment debtor in the civil prison. The Judgment Debtor is therefore liable to be arrested and detained in civil prison.

5. It is therefore that the application at exhibit 10 is granted. Judgment Debtor is ordered to be detained in civil prison for a period of two months upon deposit of prescribed subsistence allowance by the Decree Holder. Issue warrant of arrest against Judgment Debtor upon payment of process fee.
