ORDER

The Petitioner has filed this petition U/Sec.13(3) of Karnataka Births and Deaths Registration Act 1969.

2. In the petition the Petitioner has stated he was born on **26.01.1998** at Lingammanahalli, Kadaba hobli, Gubbi taluk, Tumakur District. Due to inadvertent the birth of the petitioner was not



intimated to the Respondent authorities. The same is not entered in their registers. The birth certificate of petitioner is necessary to avail Government appointment and for other reasons. When he had applied for birth certificate, the Respondent has issued non-availability certificate. Hence he has prayed to issue direction as sought in the petition.

3. On service of petition notice, the respondent has remained absent, hence he has been placed *exparte*.

4. The following points that arise for the consideration of this court are:

1. Whether the Petitioner has made out grounds for issue directions as sought in the petition ?

2. What order?

5. The Petitioner in support of his case he has examined himself as PW.1 and relied on documents which are marked as Ex.P-1 to 3.

6. Heard the arguments of learned counsel for the Petitioner, perused the materials on record.

7. The findings of this court to the above points are as follows:



Point No.1: **In the Affirmative.**

REASONS

8. Point No.1 : In support of his case, the Petitioner has filed affidavit evidence in lieu of his examination in chief as PW.1. In his evidence he has stated that the petitioner by name **A. Jabeeulla S/o Abdul Azeez** on **26.01.1998** at Lingammanahalli, Kadaba hobli, Gubbi taluk, Tumakur District. Further deposed that due to ignorance, he has not been registered the date of birth with the respondent authorities. Further deposed that his birth certificate is necessary to avail Government appointment and for other reasons, when he had applied for the birth certificate, the respondent authorities has issued non-availability certificate at Ex.P.1. Ex.P.2 is the notarized copy of school admission certificate and Ex.P.3 is the notarized copy of Aadhar card, which clearly shows that the petitioner was born on **26.01.1998**. The evidence of Petitioner has remained unchallenged and un rebutted without under going the test of the cross-examination. Hence this court is of the opinion that the Petitioner has established that petitioner by name **A. Jabeeulla S/o Abdul Azeez** on **26.01.1998** and entitle for the relief



as sought for. With these observations this court has answered point No.1 in the **Affirmative**.

9. Point No. 2: For the aforesaid discussion on point No.1, this court proceeds to pass the following:

ORDER

The petition filed U/S. 13 (3) Registration of Birth and death Act is hereby allowed.

The Respondent is hereby directed to enter the date of birth of A. Jabeeulla S/o Abdul Azeez on 26.01.1998 at Lingammanahalli, Kadaba hobli, Gubbi taluk, Tumakur District in the relevant registers maintained by the Respondent, after collecting necessary fee if any.

Issue intimation accordingly.
