20-10-2022 This bail petition filed on behalf of petitioner, namely Noorshad @ Don has been pressed today for hearing, who has been behind the bars since 28-06-2022 in connection with Kochadhaman P .S. case no. 168/2017 registered u/s 379 of the IPC.

Learned counsel for the petitioner submitted that petitioner has been falsely implicated in this case due to high handedness of the police and there is no recovery from his possession and only on account of previous criminal history he has been implicated in this case also. He further submitted that the petitioner is languishing in custody in this case since 28-06-2022. In the light of said submissions, learned counsel for the petitioner prays for enlarging the petitioner on bail.

Learned P. P. vehemently opposed the prayer for bail submitting that this petitioner has been involved in large number of cases which are exceeding 16 cases which are as under :-

He further submitted that this petitioner is a professional offender and thus prayer for bail should not be entertained.

Primarily considering the submission that this petitioner is involved in not less than 16 cases of similar nature which are from year 2017 to 2022 and prayer for bail in some other session trial cases have recently been rejected by this court and as such this court does not find it proper to extend the privilege of bail to this petitioner at this stage.

Thus, the bail petition of the petitioner, namely Noorshad @ Don is hereby **dismissed**.
